BOARD APPROVES THE MACAW RECOMMENDATION TO MOVE TO IIS VALIDATION

After discussions with the IIS Community, including AIM, Program Managers, and partners, the AIRA Board has approved the MACAW recommendation to introduce a validation process in place of voluntary certification.

More details will be forthcoming, but included below is a short summary of the approach:

- Validation will be automatically achieved when a participating IIS is assessed and meets the selected measures and tests in a specific phase (e.g., transport, submission, query, etc.)
- Validated IIS will be provided with a formal statement that can be used on marketing materials, and sites will be recognized at AIRA events
- Measurement reports will acknowledge interim steps including “major differences” and “minor differences” with standards – major and minor differences will be determined by MACAW and approved by the Board

NDC AND LOT NUMBER RESOURCES

As many IIS and Electronic Health Record Systems (EHRs) across the community develop and enhance National Drug Code (NDC) functionality and inventory decrementing using NDC and/or lot numbers, we wanted to take a minute to remind our members of two important resources available to guide both development and messaging:

CDC, in collaboration with AIRA community input, developed a helpful resource last summer titled [Updated Guidance for Documenting Vaccine National Drug Codes \(NDCs\) and Lot Numbers in IISs and EHRs](#). This guidance was published in June 2017, and is available for both immunization providers and city/state IIS staff.

AIRA, via the Standards and Interoperability Steering Committee (SISC), then published [Vaccine Lot Number Patterns: Unit of Sale/Unit of Use Guidance](#) in July 2017. This document replaces earlier MIROW guidance on using pattern matching to link Unit of Use (UoU) and Unit of Sale (UoS) lot numbers across the industry.

One or both of these resources may be helpful to better manage and message code set and inventory topics internally and with external partners.

THE ADVISORY COMMITTEE ON IMMUNIZATION PRACTICES (ACIP) OCTOBER MEETING SUMMARY

The Advisory Committee on Immunization practices (ACIP) met October 25-26 with four votes, a couple important updates, and numerous informational discussions on the agenda which will likely impact your IIS.

Votes

The following policy votes were taken by ACIP and will become official when their MMWR's are published in the coming months.

- **Herpes Zoster:** ACIP voted to recommend a two-dose schedule for a new Herpes Zoster subunit vaccine (HZ/su), brand name Shingrix, in immunocompetent adults aged 50 years or older. It was further recommended that this vaccine be preferred over the current live zoster vaccine (ZVL), and HZ/su should be given to patients who previously received ZVL.
- **MMR:** ACIP voted to recommend a 3rd dose of MMR to persons previously vaccinated with two doses of a mumps-containing vaccine and are identified by public health as at increased risk for mumps because of an outbreak.
- **2018 Adult Schedule:** As is customary at the October meeting, the annual adult schedule was approved by ACIP. The adult schedule harmonizes all of the adult recommendations of ACIP into one succinct document. Publication typically occurs in January or February.
- **2018 Childhood and Adolescent Schedule:** Similar to the annual adult schedule, an annual childhood and adolescent schedule was also voted on and approved by ACIP. The childhood and adolescent recommendations harmonize all of the birth through 18 recommendations of ACIP into one succinct document.

Important Updates

The following product updates were provided by ACIP during the meeting.

- **Afluria Quadrivalent:** Afluria Quadrivalent (IIV4, Seqirus) was previously licensed for ages 18+ is now licensed for 5+.
- **Menomune Discontinuation:** Menomune (MPSV4, Sanofi Pasteur) is now discontinued with the last lots expiring in either June or September 2017. More information can be found [here](#).

Informational Discussion

One informational discussion of note is the potential introduction of a new Hep B vaccine (Hepislav-B, Dynavax) for patients aged 18+ which can be administered as a 2-dose series. ACIP will continue to monitor this vaccine, but no formal recommendations have been voted on by ACIP at this time. It should be further noted that Hepislav-B is still working towards FDA approval.

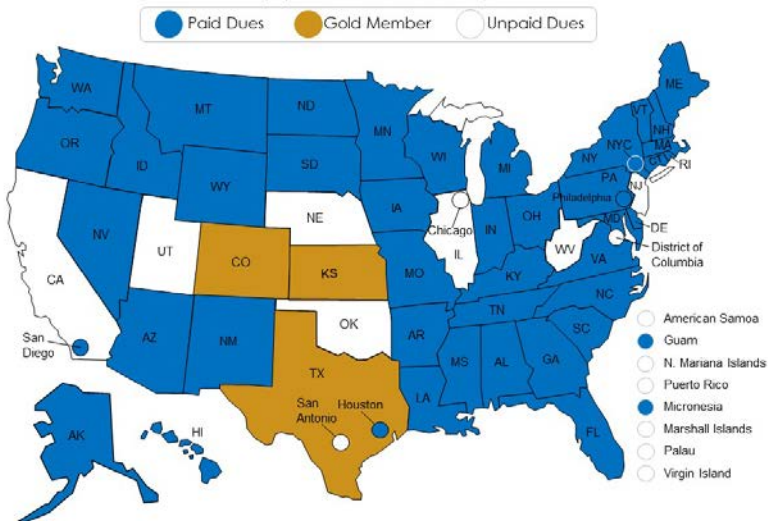

OCTOBER RECAP

Assessment Steering Committee

- The Assessment Steering Committee (ASC) is launching a project to develop a new coverage assessment guide. The purpose of the guide is to help IIS and immunization program staff identify actual pockets of need using local area coverage assessment analyses and determine when to take action.

- The ASC meets on quarterly basis and the next meeting will be held on December 5th at 2pm ET.

Standards and Interoperability Steering Committee

- The Standards and Interoperability Steering Committee (SISC) met on October 11th and discussed standardized error codes and expectations for error-generating and error-receiving systems. The committee also conversed how to handle MVX codes when a vaccine is sent from a relabeler. Discussion on this topic will resume on the next call.
- The SISC Technical Workgroup met on October 27th and reviewed AIRA's draft comments on ONC's 2018 Interoperability Standards Advisory. The workgroup also continued to discuss comments related to required LOINC codes, dose validity and required message types.

Education Steering Committee

- The Education Steering Committee (ESC) met on October 18th and received an update from the Public Health Informatics Institute's Informatics Academy. Currently, articles are also being accepted for the next edition of Snapshots. Looking ahead, the committee discussed the focus of ESC webinars and topics for the upcoming year. A draft of the education plan being based on 2017 Education Survey results was also reviewed.

MIROW Steering Committee

- The MIROW Steering Committee (SC) met on October 19th to review action items and next steps that were a result of the in-person strategic planning session held in August.
 - The SC finalized the implementation plan and will be presented to the AIRA Board for approval. This implementation plan will help outline MIROW activities for the next year.
 - The current topic, Consolidating Demographic Records and Vaccination Event Records, has been finalized and published. See separate article outlined in this monthly update issue for more details.
