AIRA REGIONAL MEETING IN HAWAII A SUCCESS



AIRA held a two-day Regional Meeting for Hawaii and the Pacific Islands in Honolulu, Hawaii on July 11th & 12th. The Regional Meeting provided an opportunity for training, mentoring, specialized assistance, and for participants to engage with colleagues from the region and discuss shared issues. Participants

included representatives from Hawaii, Guam, Palau, Federated States of Micronesia (FSM), Commonwealth of the Northern Mariana Islands (CNMI), Republic of the Marshall Islands (RMI), American Samoa, CDC representatives and representatives of Envision, HLN Consulting and HPE. There were many engaging discussions over the course of the two days on a wide range of topics, including business requirements and the IT life cycle, key aspects of inventory management, coverage assessment using IIS data, interjurisdictional data exchange, and business plan development. Overall the two-day meeting was a very satisfying and productive experience and attendee evaluations were all extremely positive.

PHII HOSTS IIS LEADERSHIP TRAINING FOR PACIFIC ISLANDS

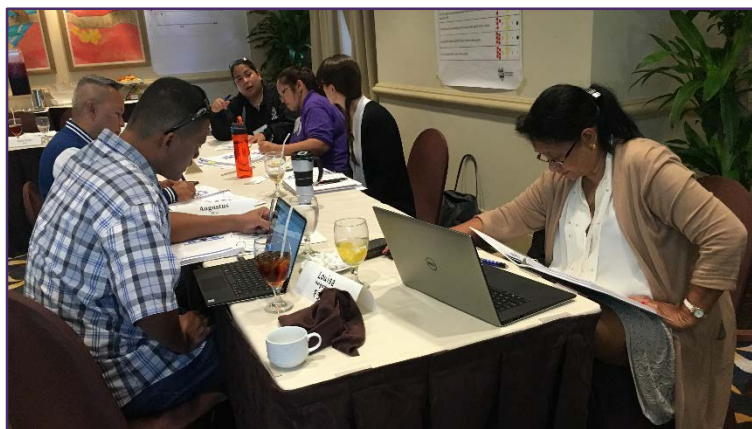
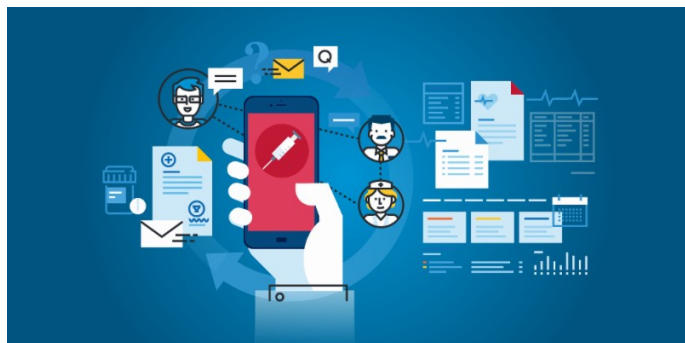

Thirteen participants (eleven IIS Program Staff and two CDC Public Health Analysts) spent three full days attending the Fundamentals of IIS Leadership Training at the Guam Hilton in Tumon Bay June 27-29, 2016. This training was provided by the Public Health Informatics Institute (PHII). Participants included representatives from Guam, Palau, Federated States of Micronesia (FSM), Commonwealth of the Northern Mariana Islands (CNMI), Republic of the Marshall Islands (RMI), and American Samoa. The curriculum was closely

JULY RECAP

Assessment Steering Committee

- The Assessment Steering Committee (ASC) met on July 5th and received a progress update on the addendum to the [Analytic Guide for Assessing Vaccination Coverage Using an IIS](#). The *Data Validation Guide – For the IIS Onboarding Process* was sent out for external review and comments are due back to [Sherry Riddick](#) by August 12th. Standards and Interoperability Steering Committee

- The Standards and Interoperability Steering Committee (SISC) met on July 13th and reviewed the proposal to ballot the Implementation Guide through HL7. The committee was given the opportunity to ask questions and discuss the details of the process. The SISC Technical Workgroup meeting on July 27th served as another opportunity to receive additional feedback and to hear from other groups who have balloted documents through HL7.

Education Steering Committee

- The Education Steering Committee (ESC) met on July 20th and reviewed the first draft of the 2016 AIRA Education Survey. This survey is conducted every two years and is sent out to the AIRA membership to assess the community's education needs and interests. The survey results are used by ESC and other committees to identify and plan future focus areas.

MIROW Steering Committee

- The MIROW Steering Committee met on July 21st to review the high level results of the community survey on Consolidated IIS Records. Thirty responses were captured and the data is being analyzed further. Additionally, steering committee members updated the MIROW Charter and will present the recommended updates to the AIRA Board next month. As part of AIRA's cooperative agreement with CDC, AIRA is working on an evaluation of the MIROW process. Three surveys have been conducted as part of the last topic and AIRA is in the process of formalizing and summarizing the results. The MIROW Steering Committee will have a chance to help review and contribute content to the evaluation results once they are finalized.
