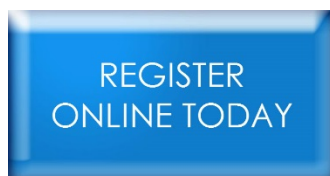

Beginning on Wednesday, January 6<sup>th</sup>, we will be accepting nominations for two categories of awards:

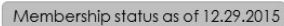
- **Centers of Excellence Awards (2016)**

## COOPERATIVE AGREEMENT KICK-OFF MEETING

On December 9<sup>th</sup> and 10<sup>th</sup>, AIRA staff attended a Cooperative Agreement kick-off meeting in Atlanta, GA with CDC/IISB leadership. The first day of the meeting focused on the IIS Capacity Building & Operations Support Cooperative Agreement AIRA was recently awarded. Discussion centered around the activities AIRA has planned for the first year of this cooperative agreement, such as the data quality evaluation work the Assessment Steering Committee is supporting and the creation of consensus-based IIS operational guidelines that are in development by the Standards & Interoperability Steering Committee (SISC) and the Modeling of Immunization Registry Operations Workgroup (MIROW).

The second day of the meeting focused on the activities AIRA has planned for the second year of its Standards Cooperative Agreement, the purpose of which is to enhance standards support for the IIS community. Work plans and timelines were discussed for each of the five key objectives of this cooperative agreement, including the joint/collaborative development initiative and the interoperability testing project currently underway. This kick-off meeting allowed AIRA and CDC staff the opportunity to discuss in detail the plans, strategies, and activities over the coming year that will support the objectives set forth by the two cooperative agreements AIRA received.

## JOINT DEVELOPMENT & IMPLEMENTATION (JD&I) WORKGROUP PROJECT SELECTION

At the in-person meeting in October, the Joint Development Advisory Workgroup explored three candidate projects, and selected one project to serve as a proof of concept to forward on to the AIRA Board for approval. At the AIRA Board's December meeting on December 7<sup>th</sup>, the Board approved the selected project, so a small working group has been convened to scope and launch this project into action. The project focuses on address cleansing and geocoding, and is striving to develop guidance and offer a centralized service to support address cleansing. The project's preliminary scope has four primary components:

- Address correction in accordance with USPS
- Address completeness and accuracy (addressing missing or mismatched data)
- Geocoding
- Phone number clarification (tracking multiple phone numbers, differentiating between land lines and mobile lines)

The Advisory Workgroup also drafted a new core challenge statement that further focuses JD&I's work on implementation:

*Leverage and share resources to improve the consistency, quality, and/or cost effectiveness of IIS implementation projects*

Additional small working groups have been convened to address other lanes of JD&I's strategic plan, including governance, communications, and the knowledge repository that will support this collaborative work.

Outreach is underway to gather lessons learned from across the community about current practices in use. ## DECEMBER RECAP

### Assessment Steering Committee

- The Assessment Steering Committee (ASC) met on December 1<sup>st</sup>. The committee reviewed proposed scopes for a list of candidate data quality projects and decided to move forward with the development of a quality assurance implementation guide. The AIRA staff and a few ASC volunteers will further develop the project scope and present it at the January 5<sup>th</sup> meeting.

## Standards and Interoperability Steering Committee

- The Standards and Interoperability Steering Committee (SISC) and the Technical Workgroup combined their meetings on December 16<sup>th</sup>. The SISC began discussing the timeline for the release of the next version of the Implementation Guide. After much discussion the committee decided to create a list of proposed topics and determine which topics require a shorter or longer timeline. This discussion will be revisited in early 2016 to put together a more concrete timeline and goals.
- The SISC also discussed the NK1 Segments relationships and roles. The goal of the discussion was to get an understanding on what data the IIS is trying to extract from the NK1 statements, and what assumptions are being made about the role of the person in the NK1. The next step for the SISC will be to follow up and try to put definitions around these roles (i.e. legal guardian, care giver, next of kin).

## Education Steering Committee

- The Education Steering Committee (ESC) met on December 16<sup>th</sup>. The ESC is currently working to find dates and locations for two Regional Meetings in 2016.
- The ESC will be hosting a webinar on AFIX-IIS Guidelines on Tuesday, January 12<sup>th</sup> at 3:30 pm ET. Details for this webinar can be found on the AIRA website [here](#). The ESC will be hosting another webinar on February 29<sup>th</sup> that will provide an introduction to VTrks ExIS Usability Best Practice Catalog.

## MIROW Steering Committee

- The MIROW Steering Committee (SC) met on December 17<sup>th</sup> and voted on the next topic for development. A basic scope was discussed and will be finalized in the coming months. The current chapter "Decrementing Inventory via Electronic Data Exchange (DI-v-EDE)" is still underway with a goal of being ready for internal review in late January. Once the internal review process has been completed, the document will then be released for external (community) review. The next monthly call is scheduled for January 21, 2016.
