#### ONC INTEROPERABILITY ROADMAP

#### HL7 POLICY CONFERENCE

Alison Chi, AIRA Program Director, attended the HL7 Policy Conference, *Building the Future: Innovation & Interoperability*, held on December 4<sup>th</sup> & 5<sup>th</sup> in Washington, D.C. The conference covered topics that included incentivizing interoperability, and lessons learn in the eHealth and HIT revolution with a focus on standards and interoperability. The keynote speaker, The Honorable Diana DeGette (D-CO) spoke about a new bill that she is sponsoring that is intended to facilitate safe data sharing and create a central patient registry to help coordinate medical research. Other topics included a patient-centric focus on interoperability, standards maturity, and a discussion of case reporting, informatics and interoperability in the context of the Ebola crisis.

#### NOVEMBER RECAP

#### **Assessment Steering Committee**

• The ASC met on December 2<sup>nd</sup>, 2014. The ASC previously decided to create a guide that would direct any individual or IIS through the decisions that need to be made to conduct coverage assessments using an IIS. A small working group of subject matter experts, including several epidemiologists, was created to work on this project. The working group discussed the scope of the guide during their initial meeting. The due date for a finalized document is August 31, 2015.

### Standards and Interoperability Steering Committee

- The SISC met on December 10<sup>th</sup>, 2014. The SISC discussed standards for NIP001: adding new codes versus modifying the language of existing codes to be more inclusive. The membership opted to modify existing codes.
- An update was provided on the creation of a functional guide that can be used as the
  basis for creating a testing system of IIS and EHR HL7 interface testing for immunizations.
  This project is being funded by the National Institute for Standards and Technology
  (NIST). It is important to note that NIST will not set standards for IIS. Instead they are
  asking for clear documentation on IIS standards that they can use as a basis for the

- testing system they will create for IIS. The functional guide together with the messaging guide will then become the documents that communicates the interface expectations from the community to NIST and which NIST will use to defend their testing methodology.
- After much discussion regarding National Provider Identifier numbers during the SISC meeting, it was agreed that while utilizing NPIs is an interesting idea, there is not strong support to put effort into requiring NPI into IIS systems.

#### **Education Steering Committee**

- The ESC met on December 17<sup>th</sup>, 2014. ESC members discussed the evaluations received regarding the IIS-AFIX webinar held on December 2. Seventy-nine participants attended the IIS-AFIX webinar.
- The Provider Training Work Group finalized their document on training resources to support IIS trainers. The document has been posted on the AIRA website: http://www.immregistries.org/resources/technical-assistance.
- AIRA is planning on holding a regional meeting in June 2015. Stay tuned for more information about this meeting.

#### **MIROW Steering Committee**

• The MIROW Steering Committee met on December 18th, 2014. The steering committee discussed the Patient active/inactive status topic guide, the topic for the next development cycle (Correction of missing inventory data by providers when information in the HL7 message does not match the IIS inventory); avoiding manual updates.), MIROW activities at the AIRA 2015 National Meeting, evaluation of MIROW guides, and continued discussions on the development approach going forward.
