NATIONAL QUALITY FORUM DRAFT REPORT: PRIORITIZING MEASURE GAPS FOR ADULT IMMUNIZATIONS

The National Quality Forum (NQF) issued a request for comments on a project report for an initiative to identify critical areas for vaccination performance measurements across adult populations. Overall, AIRA is very supportive of NQF's statements about the role that IIS can play in improving and measuring adult immunization coverage, and their recognition that expanding use of IIS for adult immunizations will require more funding. Mary Beth and Amy Metroka presented on portions of the CDC IIS Executive Board, Jane Zucker gave an excellent presentation on how the IIS is utilized within the entire NYC immunization program and Rebecca Coyle gave an update on the AFIX project.

JULY RECAP

Assessment Steering Committee

- The ASC met on July 1st, 2014. The committee is tasked with overseeing a project to adapt the Data Quality Assurance tool (DQA)developed by Dandelion Software & Research, Inc. to serve as a 3rd party tool to assess IIS data quality. The committee continued development discussions during the July meeting. A revised data quality report and installation option proposal will be shared with committee members during the August ASC meeting.
- The committee will be piloting the Data Quality Assessment Tool in coming months and welcomes additional pilot sites. If you are interested in participating in the pilot, please email Alison Chi at achi@immregistries.org
- Committee members also began discussing 'micro' topics for a coverage assessment best practice micro guide to be developed over the next year.

Standards and Interoperability Steering Committee

• The SISC did not meet in July. The next SISC meeting will be on Wednesday, August 13th from 12 – 1 p.m. ET/9 – 10 a.m. PT.

Education Steering Committee

- The ESC met on July 16th, 2014. Committee members reviewed initial findings from the 2014 Education Survey and continued work on the survey report and education plan which will be based on these findings.
- Integration of the ESC and the Provider Training Workgroup, a subcommittee of the ESC, was unanimously approved. This integration is expected to better leverage resources and increase participation of IIS trainers in the overall development of AIRA's education strategy. Provider Training Workgroup members were warmly welcomed to the July 16th ESC meeting.
- Committee members are planning for an educational webinar that will be offered in September: IIS Provider Training & Evaluation Programs in 2 States.
- Committee members continued development of a training guide, the first section of which will focus on trainer training.

MIROW Steering Committee

- The MIROW Steering Committee met on July 17th, 2014.
- The steering committee discussed the Evaluation of MIROW guides the final report was delivered on July 31, 2014.
- Information from the SME meeting (patient active/inactive status (PAIS) topic guide) that was held in June was shared.
- The Lot Numbers validation Micro-Guide is now posted on the AIRA website
- MIROW activities for the AIRA post-NIC meeting were discussed.
