JOINT DEVELOPMENT MEETING

Members of the IIS community met last week in Atlanta at the Public Health Informatics Institute for the Developing a Framework for Joint IIS Development Collaboratives meeting. The group defined the term, joint development, in the context of IIS; identified areas of IIS that may best be addressed by joint development; and identified action steps to address funding, contractual, and operational barriers. This is the first step in this project; the next step will be engaging the IIS vendors for their input on this important topic. We hope to incorporate some of the information from the two day meeting into our Denver meeting.

CDC STACKS - A NEW PUBLIC HEALTH RESOURCE

Did you know that <u>CDC Stacks</u> is an online digital repository of CDC supported publications? CDC Stacks is a free, digital repository of publications produced by the Centers for Disease Control and Prevention (CDC) based on scientific research. This online library can be found at http://stacks.cdc.gov. CDC Stacks is composed of curated collections of full-text peer reviewed articles, guidelines and recommendations, and many more documents on a broad range of public health topics. The documents are retained indefinitely and are available for public health professionals, researchers, as well as the general public.

Fully-featured Repository with Search and Suggested Links

CDC Stacks provides the ability to search the full text of all documents, browse journal articles by public health subject, and explore the curated collections of nearly 10,000 articles and documents on relevant topics.

JULY RECAP

Assessment Steering Committee

• The ASC did not meet in July. The next meeting will be on August 6th from 2 – 3 p.m. ET.

Standards and Interoperability Steering Committee

- The SISC met on July 17th, 2013. The committee continued ongoing review of proposed HL7 Implementation Guide (IG) changes and voted in favor of a proposal regarding query/response messages and the specification of profile(s) for requesting an immunization history. The committee voted to specify one profile that all can support, which will need to have significant portions that have a usage of optional (O). Each IIS will then need to create a profile on top of this that constrains the national standard profile. This profile will need to include requirements that support evaluated history and forecast in order to support expected Meaningful Use 3 requirements.
- The SISC began an discussion and review to standardize ACK messages and codes used by IIS and data exchange partners.

Education Steering Committee

- The ESC met on July 17th, 2013. The ESC is serving as the planning committee for the AIRA National IIS Meeting in Denver in October. Center of Excellence award topics were reviewed.
- Committee members finalized plan for the next educational webinar which is scheduled for August 28th at 3pm ET. The topic for this webinar is HL7 101. A flyer for this webinar can be found here.

MIROW Steering Committee

- The MIROW Steering Committee met on July 18th, 2013. The committee conducted indepth discussion of project materials prepared by the University of Michigan for the evaluation of MIROW guides.
- A possible small-scale MIROW topic validating and 'cleaning' lot numbers was discussed.
