HL7 explains "this landmark decision represents HL7's commitment to the betterment of healthcare worldwide by ensuring that all stakeholders have equal access to its HIT standards."

AIRA will continue to maintain an HL7 membership, which enables us to influence the development of standards, as well as provide access to HL7 resources, tools, and community.

### AIRA STRATEGIC PLANNING AND IN-PERSON BOARD MEETING

Sixteen people representing the AIRA Board of Directors and AIRA staff met from March 12 - 14, 2013 in Portland, Oregon to discuss the needs of the organization and draft a strategic plan for the coming years. Participants reviewed the current state of the organization, the previous strategic plan, the cooperative agreement with the CDC, and other background information. After this discussion, the group worked together to draft a revised mission statement, create specific goals for the new strategic plan and draft prioritized objectives under those goals.

The five new strategic goals for AIRA are:

- Increase Financial Capacity
- Ensure Organizational Stability
- Maintain Role as Leading Authority
- Support our Members
- Fully Engage Community and Partners

The Strategic Planning Committee and the Board of Directors will finish development of the new AIRA Strategic Plan in coming months, and it will be shared with members as soon as this process has been completed.

### MARCH RECAP

### **Assessment Steering Committee**

- The ASC met on March 5, 2013. The committee reviewed and approved the 2013 ASC Charter. The committee also reviewed and approved final changes for the coverage assessment investigation and analysis RFP, which was then issued on March 25<sup>th</sup>, 2013 and can be found in the Opportunities section of the AIRA website: <a href="http://www.immregistries.org/job-opportunities">http://www.immregistries.org/job-opportunities</a>. Proposals are due April 22<sup>nd</sup>, 2013.
- The ASC began discussion on the development of a 3<sup>rd</sup> party data quality tool, a cooperative agreement activity for which this committee is responsible. Committee members agreed that the scope of the tool needs to be identified, after which the methodology can be developed.

## Standards and Interoperability Steering Committee

• The SISC met on March 6<sup>th</sup>, 2013. The Committee also held an ad hoc meeting on March 4<sup>th</sup> to review HL7 Implementation Guide (IG) revisions. During the March 6<sup>th</sup> Steering Committee meeting, committee members reviewed possible MSH-22 changes, a proposed VFC eligibility code, HL7 processing rules, and new CVX codes. During the March 4<sup>th</sup> ad hoc meeting committee members discussed a proposal to pre-adopt HL7 V 2.7.1 MSH definitions, and a proposal to support the return of just the evaluated history and forecast in preparation for query/response messaging.

### **Education Steering Committee**

• The ESC met on March 20<sup>th</sup>, 2013. Committee members planned the next issue of SnapShots. The ESC also discussed changes in the Online Training Subcommittee, for which a scope was developed and approved and which is now called the Provider Training Workgroup. The purpose of the workgroup is to provide a forum for training practices, including online training and other methodologies. Tammy Pilisuk, CA and Jenne McKibben, OR, will co-chair this workgroup.

#### **MIROW Steering Committee**

• The MIROW Steering Committee met on March 21st, 2013. The committee finalized the mini-guide content for the inventory management topic, discussed progress on the current data quality assurance topic.
