What is CIIS?

Confidential web-based system that:

- Consolidates immunization records for Coloradans of all ages.
- Recommends the vaccines a patient needs based on history and age.
- Supports activities to increase and sustain high immunization coverage rates.

CIIS by the Numbers

- Total Patients: 4,522,039
 - 0-18 year olds: 1,675,504 (37%)
 - 19+ year olds: 2,846,535 (63%)
- Total Vaccinations: 48,822,912
 - 0-18 year olds: 31,654,764 (65%)
 - 19+ year olds: 17,168,148 (35%)
- Total Opt-Outs: 1,408
- Active Users: 4,244



CIIS Background Information

- June 2011- New CIIS Web Application went live.
- Participation in CIIS is voluntary for both providers and individuals.
- Current provider participation in CIIS as of March 2015:
 - 1121 clinics reporting immunization data
 - 33% are manual users
 - 67% are electronic
 - 100% participation from the Local Public Health Departments

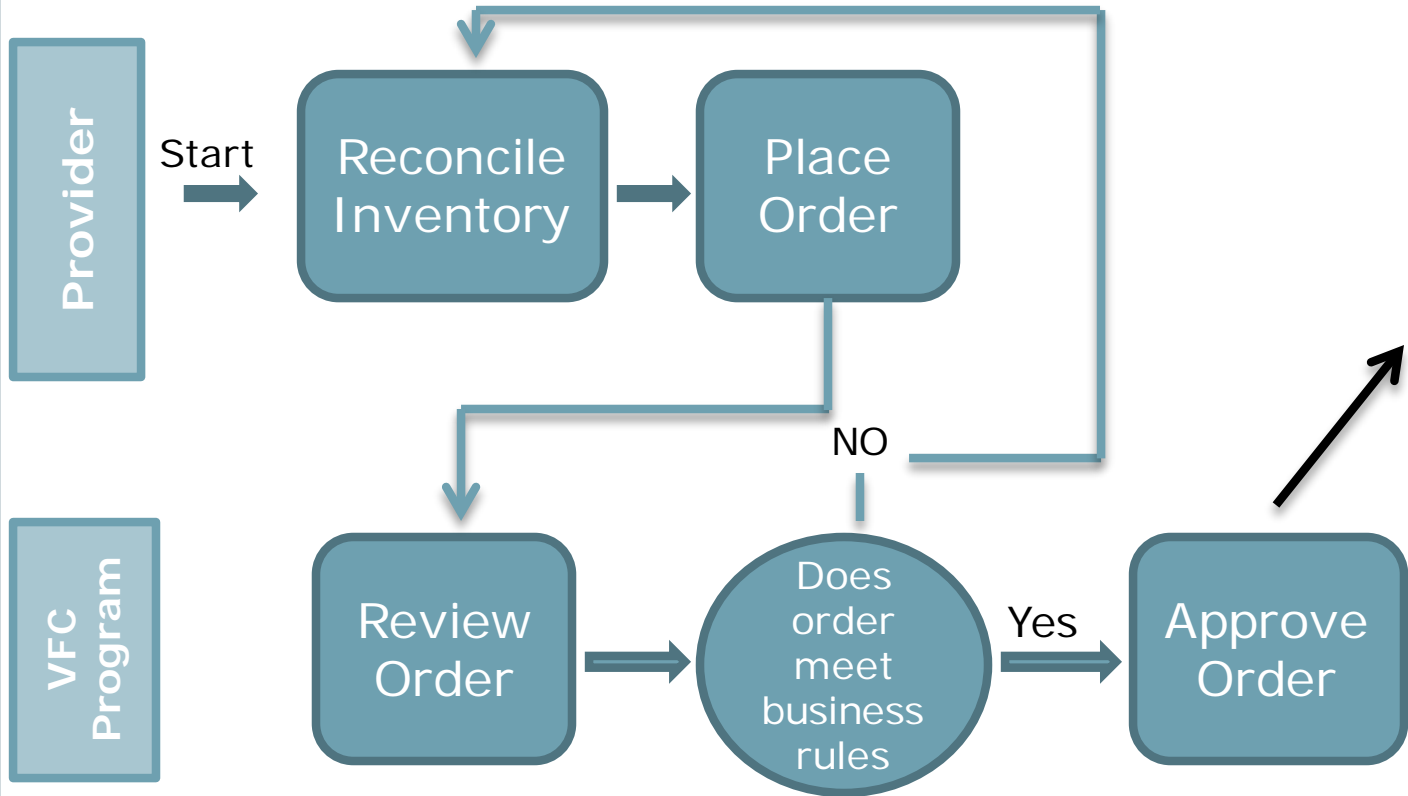
History of VFC Vaccine Ordering in CO

Celebrating Success

During 2014:

- 526 VFC clinics have placed at least one vaccine order in CIIS.
- 762,689 doses were distributed through CIIS.
- These doses are valued at over \$42.3 million.
- The VOM Help Desk has responded to 2,180 technical assistance calls.

Pilot Phase Project Timeline

- Build a pilot phase into the project timeline to better identify and troubleshoot problems that might arise during the deployment phase.

A pilot phase helps you:

- Determine whether your proposed rollout timeline is realistic.
- Identify topics/concepts that need to be emphasized in the training.

Lessons Learned Cont'd

- Build training capacity to allow for staff turnover at the clinics.
- Need for a permanent VOM help desk.

Help Desk Call Log

- VOM staff keeps a call log to track the number and kinds of calls received by the help desk. This helps us:
 - Monitor reoccurring user issues and trends
 - Track changes in call volume

Counting Your Physical Inventory for Reconciliation

- Count doses in your storage unit by **LOT NUMBER**, not just vaccine type.
- Have two staff members work together: one to count doses and one to record. This has the added benefit of cross-training.
- Double-check your physical count before you walk away from your storage unit.
- Use your physical count to inform your VFC vaccine order.
- Count inventory after all vaccines have been administered for the day or first thing in the morning before vaccine activity occurs.

When to Perform Your Reconciliation

- Reconcile your VFC inventory **at least monthly** regardless of how often you order VFC vaccine.
- Do **NOT** wait until the last day of ordering (21st of every month) to reconcile your inventory.

We may be unable to resolve serious issues with your reconciliation in time for you to place a vaccine order.

Reconciliation Checklist Cont'd

CIIS Vaccine Inventory Reconciliation Checklist

Instructions: Follow this checklist when you are ready to balance and close your VFC inventory reconciliation within CIIS. **Be sure to use the checklist that corresponds to your inventory user type** (e.g. CIIS Manual or CIIS Aggregate Inventory User).



It is important that you count your physical *Ending Inventory* at the end of the work day on your reconciliation *End Date* when all vaccine activity has been completed, or at the beginning of the next work day before vaccine activity occurs.

Reconcile your inventory on at least a **MONTHLY** basis, regardless of how often you order vaccine.



Tips for counting vaccine inventory:

- Pick a reconciliation *End Date* that works well with your clinic's workflow. For example, if your clinic stops giving vaccinations early on a particular day of the week, this may be a good time to count the vaccine inventory in your refrigerator and enter the count in the *Ending Inventory* column of your reconciliation in CIIS.
- Have two staff members do the vaccine inventory physical count to minimize counting errors. For example, one person could count while the other records the number.
- Double check the vaccine inventory lot numbers to verify that your count is correct for each lot number.

- Wastage and Returns Interface to VTrckS
- Edit/Delete functionality for inventory adjustments made in error.

Enhancements Cont'd

- Auto-populate “Doses Adjusted” field with a minus sign when users create inventory adjustments such as Wasted, Expired, Broke Vial etc.
