# Colorado Immunization Information System (CIIS) Notable 2013 Accomplishments

#### **HIE Interface Implementation**

- Unilateral HL7 batch file through CORHIO
- Two years in the making

#### **Interagency Collaboration**

- Newborn Hearing and Metabolic Screening Programs
- Women, Infants, Children Program
- Office of Emergency Preparedness and Response

#### **Indian Health Services Interface**

- Marks first time IHS has submitted data to CIIS
- Lays the groundwork for bidirectional exchange

## CIIS Studies and Research In Collaboration with University of Colorado- Denver

2010-2011

•A National Institutes of Health funded randomized controlled comparative effectiveness trial that compared a centralized reminder/recall approach with a practice-based reminder/recall intervention in 14 Colorado counties for infants and toddlers.

2011-2014

 A group randomized trial at the county level comparing collaborative centralized reminder/recall and practice-based reminder/recall for 19-35 month olds in 16 Colorado counties.

2013-2018

• Affordable Care Organization/Public Health Collaborative Preventive Care Delivery to Priority Populations – this project will extend centralized reminder/recall to adolescents and adults within ACOs.

## Senate Bill 13-222 (SB 222)

Enables CDPHE to establish a vaccine purchase system

Creates an immunization fund for the purpose of purchasing vaccines, supporting users of the immunization tracking system, and other immunization activities

Authorizes CDPHE to convene a task force to examine options for maximizing federal vaccine funds and improving statewide purchase, distribution and delivery of vaccines to insured, underinsured, and uninsured individuals

Permits CDPHE to purchase recommended vaccines through a vaccine purchasing system, if such a system is developed

## Personal Belief Exemption (PBE)



Required education through provider (licensed to give immunizations) / public health counseling or online computer-based training (CBT) prior to claiming a PBE



CDPHE would publicly report immunization and exemption rates by school and childcare center
