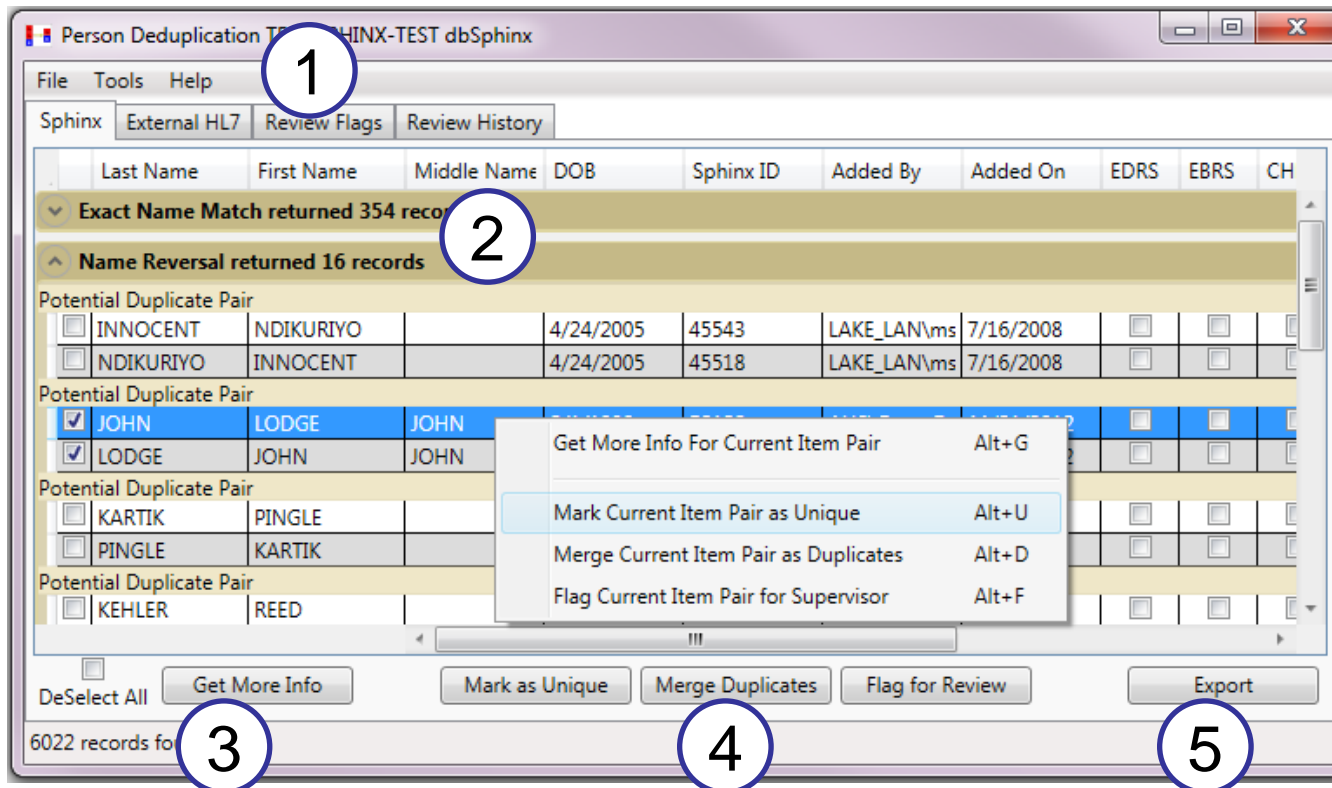

Project Vision

- Goals
 - Reduce manual processing time
 - Improve internal data quality
- Challenges
 - Allowing multiple users
- Key Innovations
 - Marking non-duplicates as **Unique**
 - Soundex and Tokens **Algorithms**

Tool For (Automated) Manual Review



State Assets

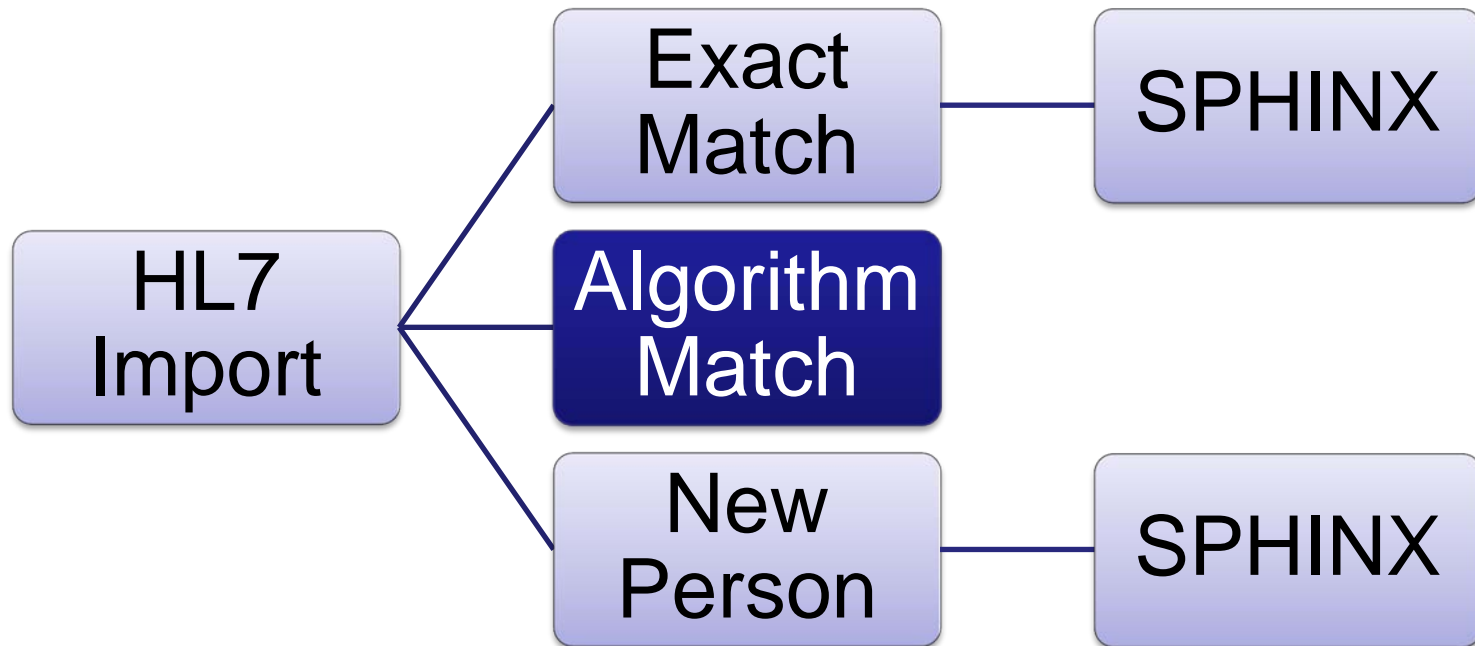
- Relatively Small Size
- SPHINX - Combined Demographic Data
 - Immunization Registry
 - Electronic Birth Registry System
 - Electronic Death Registry System
 - Child Hearing Screening
 - Lead Registry
 - Newborn Bloodspot Registry

Process Outline

- Check all records in nightly batch
- Display potential pairs in application
- Reviewers investigate and take action:
 - Mark as Unique
 - Merge as Duplicates
 - Flag for Manager Review

Incoming Records

- Hold bad data for further review



Matching Algorithms

- Exact Name Match
- Name Reversal
- Name Parts Missing
- First Name Typo
- Name Typo Hyphen
- Name Change
- Date Of Birth Typo
- Soundex Match First Name
- Soundex Match Last Name
- Name Tokens

Algorithm - Soundex

- Phonetic Algorithm for indexing
 - First Letter + 3 Digit 'Sound'

SOUNDEX()	Matt	Mat	Matthew	Max
Keep first letter	M att	M at	M atthew	M ax
Drop vowels and H/W	Mtt	Mt	Mtt	Mx
Replace consonants with digits	M33	M3	M33	M2
Remove pairs	M3	M3	M3	M2
Pad to 4 characters	M300	M300	M300	M200

Algorithm - Tokens

- Puts all fields in large bin
- Must match on (n-1) fields

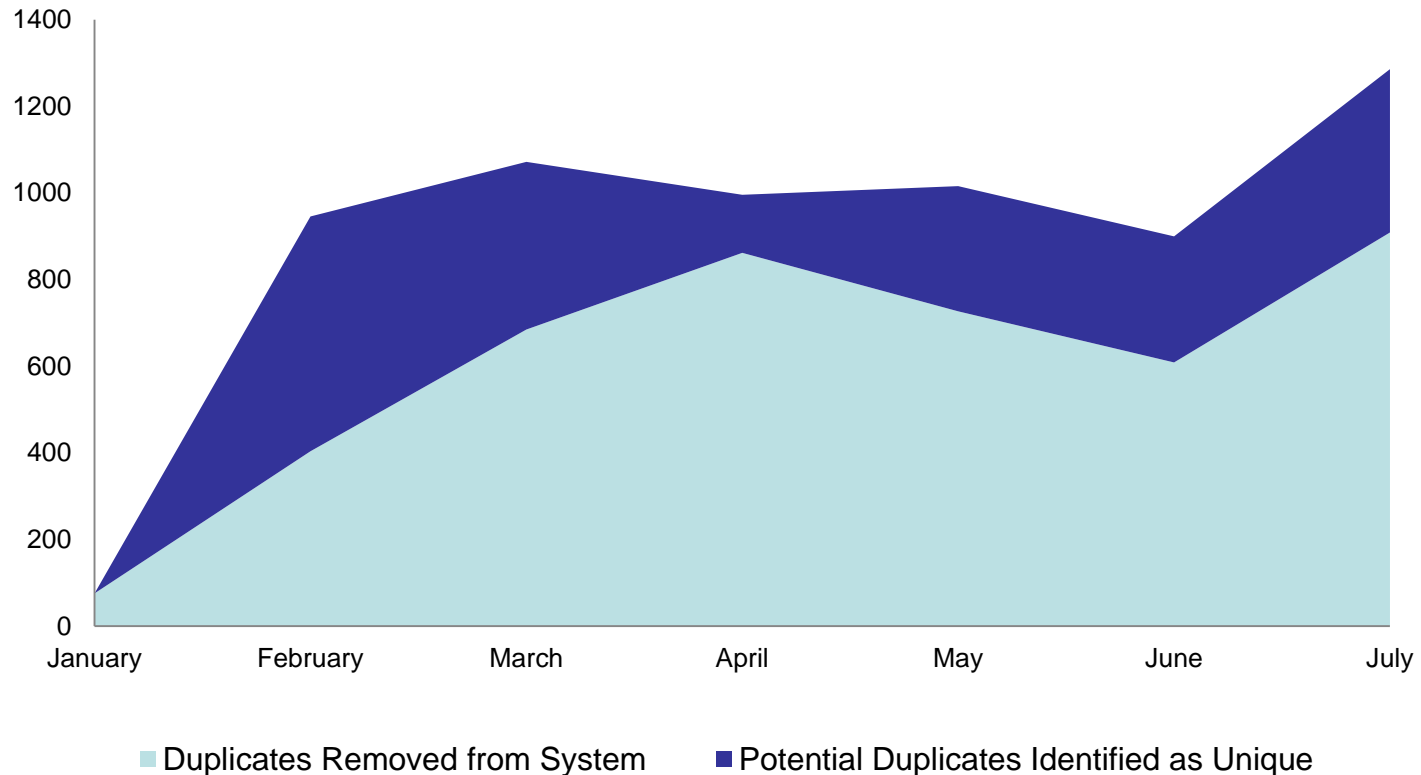
First Name	Last Name	Middle I.	Mother
Bob	Jones	A	Leanna
Jones	Leanna	C	Bob

Manual Audit

- Log all actions performed
 - Failed and Successful
- Available for view and reports
