




















STRENGTHEN YOUR TIES WITH VITAL RECORDS

- Most state registries connect to Vital Records
- Work to improve timeliness (ideally, two weeks or less)
- Get death and adoption records
- Collect Birth Dose Hep B through vital records interface



STRENGTHEN YOUR TIES TO MEDICAID

- \$\$\$
- 90/10 match
 - Funds can be used to purchase servers, analytic tools and shared services/modules
 - Funds can also be used for staffing
- Data may be useful to help populate your system, provide analytics, etc.



STRENGTHEN YOUR TIES TO WIC

- Every WIC child is screened for immunizations
- Your system can be the tool for screening/validation
 - Ideally through real-time query



STRENGTHEN YOUR TIES WITH EARLY HEARING DETECTION INTERVENTION (EHDI)

- Most birth records contain hearing screening results
 - Some IIS are capable of receiving and storing these data
- EHDI may have funds to share



STRENGTHEN YOUR TIES WITH LEAD

- Most children are screened for lead exposure at least once
- Children covered by Medicaid may be screened routinely
- Link to LEAD database and display the screening results for physicians



STRENGTHEN YOUR TIES WITH NEWBORN SCREENING

- Newborn screening provides another opportunity to have a one-stop data shop for physicians
- Display newborn screening results through the User Interface




STRENGTHEN YOUR TIES WITH CENTRAL IT

- Central IT may or may not be in a separate agency
- Central IT manages:
 - System Infrastructure (always)
 - System Developers (sometimes)
 - Vendor Contracts (usually)
- It's wise to have a good working relationship (and working understanding) of each other's business



STRENGTHEN YOUR TIES WITH CHRONIC DISEASE

- BMI Data (height and weight)
- A1C Data (diabetic measure)
- Work to help your IIS meet their needs



STRENGTHEN YOUR TIES WITH COMMUNICABLE DISEASE

How can the disease surveillance system become interoperable with the IIS?

- Share Hepatitis B vaccine data for Perinatal Hepatitis B follow-up
- Provide access to vaccination histories for case investigations
- Use linked data for special studies



STRENGTHEN YOUR TIES TO THE IMMUNIZATION PROGRAM


- VFC must be integrated with IIS
 - Ordering, inventory, accountability
- Work with AFIX to best use the system and improve data integration
- Train health educators and public health nurses in IIS capabilities
- Use IIS data as a source of evaluation data for federal grants




