We are pleased to announce the election results for the 2016-2017 AIRA Board of Directors:



## AIRA REGIONAL MEETING IN ATLANTA A SUCCESS

AIRA held a Regional Workshop for the Southeast Region on October 18<sup>th</sup> in Atlanta, Georgia; 29 attendees participated including AIRA staff. The Regional Workshop provided an opportunity for training and education, as well as for participants to interact with their peers from the region and to discuss shared issues. Attendees conversed about the implications and preparedness strategies for Meaningful Use Stage 3, and learned about the new data validation guide for the IIS onboarding process and shared local challenges, strategies and solutions on data quality issues. In addition, attendees heard an update on the status of interstate data exchange and participated in a discussion on communication strategies for presenting complex content to leadership. Overall the workshop was engaging and productive. Attendees consistently evaluated the workshop as positive and beneficial.

### CONFIDENTIALITY & PRIVACY DOCUMENT RELEASED



At the beginning of October, AIRA released the Confidentiality and Privacy Considerations for Immunization Information Systems document. This document summarizes different IIS confidentiality/privacy issues and provides considerations and sample forms. 
#### TOWN HALL RECORDING ON ASSESSMENT MEASURES

# CDSI CORNER: HPV & MENINGOCOCCAL UPDATES

ACIP approved a couple key schedule changes on October 19, 2016:

- Human papillomavirus vaccine: 2-dose schedule for boys and girls initiating HPV vaccination series at 9 to 14 years (0, 6-12 months); 3-dose schedule for persons initiating HPV vaccination series at older ages; 3-dose schedule for immunocompromised persons.
- Meningococcal vaccines: provided guidance on the updated dosing schedules for one serogroup B meningococcal vaccine, MenB-FHbp (Trumenba). For persons at increased risk for meningococcal disease and during serogroup B outbreaks, 3 doses of MenB-FHbp administered at 0, 1-2, and 6 months; when given to healthy adolescents not at increased risk for meningococcal disease, 2 doses of MenB-FHbp at 0 and 6 months.

If approved by the CDC Director, the recommendations will become official once published in *MMWR* later this year. At that time, the CDC CDSi project will incorporate the recommendations into the CDSi resources. # OCTOBER RECAP

# **Assessment Steering Committee**

• The Assessment Steering Committee (ASC) met on October 6<sup>th</sup> and received a progress update on the addendum to the <u>Analytic Guide for Assessing Vaccination Coverage Using an IIS</u>, and began discussing the next two phases of the data quality project. Phase II will look at incoming and outgoing data monitoring processes and phase III will look at data quality practices for data at rest. The ASC was presented with a comprehensive scope for all three phases. The ASC also decided to develop a single guide that would explain how to interpret and communicate NIS, IIS and other coverage assessment results for their next Coverage Assessment Project. The start date for this project is November 1<sup>st</sup>.

# Standards and Interoperability Steering Committee

- The Standards and Interoperability Steering Committee (SISC) met on October 12th and received an update on the Functional Guide. The first pass at the Functional Guide will be reviewed and discussed at the November SISC meeting. The SISC also discussed the idea of sunsetting the HL7 Version 2.3.1 Implementation Guide (IG). The SISC will be collecting information and resources from those who have been through this process to make them available to others to create a best practice pathway for sunsetting 2.3.1 interfaces.
- The Technical Workgroup met on October 26th and addressed a number of discussion topics, including how to send comments in a message, developing a use case for

demographic updates, and reviewing a number of updated data types. All Technical Workgroup recommendations are forwarded on to larger SISC meeting for presentation and approval. Due to Thanksgiving, the SISC Technical Workgroup meeting has been rescheduled for November 16<sup>th</sup> at 1pm ET.

#### **Education Steering Committee**

 The Education Steering Committee (ESC) met on October 19<sup>th</sup> and reviewed the latest version of the AIRA education survey which incorporated the committee's feedback from the September meeting. The ESC also began planning the next edition of SnapShots and the webinars for the next Cooperative Agreement year.

#### **MIROW Steering Committee**

• The MIROW Steering Committee met on October 20th to discuss different options for the next MIROW development cycle (2017-2018). After much discussion, the group decided to forgo working on a new topic for the next year and instead do some strategic planning for moving forward as well as developing strategies for updating current MIROW reference materials. Additionally, MIROW can free up some funds to ensure that the current topic, consolidating records, is able to finish with the full scope of demographic records and vaccination event records. The MIROW steering committee will begin to plan an interactive working session at the AIRA 2017 National Meeting to obtain input on strategies for MIROW in the future. The next regularly scheduled MIROW meeting will be held on November 17th, 2016.
