# THREE IIS PILOT NEW ADDRESS CLEANSING SERVICE

In November, the Joint Development and Implementation pilot project successfully connected three IIS to <u>SmartyStreets</u>, the address cleansing service chosen by the workgroup. Delaware, Florida and Washington State all ran sample batch data through

SmartyStreets. In the next two months, they will perform up to 500,000 address/geocoding lookups using their own data. The Joint Development and Implementation workgroup will evaluate their aggregate outcomes to determine the viability of a community-wide roll-out of the service. At

the same time, they will test User Interface and HL7 real-time connections in an effort to draft a comprehensive Implementation Guidance document for a broader launch of the

## CDSI CORNER: RESOURCES AND HPV UPDATES

The CDSi project updated two important resources recently:

- The test case resources have been expanded to include test cases for patients with underlying conditions which may indicate or contraindicate vaccination. These test cases are published as their own spreadsheet and incorporate concepts from the latest Logic Specification (version 3.0).
- The Training Material has been entirely revamped and is geared to be shorter and more pointed than previous training material, including an interactive self-assessment, quick guide, and practice exercises. The new training material can be found here: www.cdc.gov/vaccines/programs/iis/cdsi-training.html.

In October, ACIP voted to approve a 2-dose HPV schedule. The formal recommendation is tentatively scheduled to be released in a mid-December MMWR. The CDSi project will update resources soon after the MMWR is published.

### MID-COURSE REVIEW OF 2010 NVP REPORT AVAILABLE

In an email to colleagues, Bruce Gellin, MD, MPH, Deputy Assistant Secretary for Health and Director of the National Vaccine Program Office, shared that the mid-course review of the 2010 National Vaccine Plan (NVP) report is now available <a href="here">here</a>. An excerpt from Dr. Gellin's email is below:

Initially created in 1994 and updated in 2010, the NVP provides a roadmap for maximizing the impact that vaccines can have on the health of individuals and communities through a guiding vision for vaccines and immunization in the United States. This review was conducted to ensure the NVP is responsive to changes in the vaccine and immunization system as well as stakeholder priorities and progress.

The NVPO Mid-Course Review report was developed through a highly collaborative effort-- involving input from federal and non-federal stakeholders across the

immunization system. The report identifies top immunization system achievements, opportunity areas primed for near-term success, indicators to measure progress, and considerations for continued operation and coordination of the NVP.

#### NOVEMBER RECAP

#### **Assessment Steering Committee**

• The Assessment Steering Committee (ASC) met on November 1st and received progress updates on several key projects including an Addendum to the Analytic Guide for Assessing Vaccination Coverage Using an IIS, phase II of the Data Quality Project, and the new coverage assessment project. An Addendum to the Analytic Guide is estimated to be completed by the end of the year. Work has already begun for phase II of the Data Quality Project and will focus on incoming and outgoing data monitoring processes. The tentative goal is to have a draft out for review by the AIRA National Meeting in April 2017. The next coverage assessment project will develop a single guide that on interpreting and communicating National Immunization Survey (NIS), IIS and other coverage assessment results and methodologies. The first workgroup meeting was held on November 16th.

### Standards and Interoperability Steering Committee

- The Standards and Interoperability Steering Committee (SISC) met on November 9<sup>th</sup> and received an update on the Functional Guide. The first pass at the Functional Guide was presented and sent out for the committee to review. On the December call, the SISC will have the opportunity to discuss the guide's value, how it can be improved, and to identify more functional requirements that might be missing. The Functional Guide Workgroup will take this feedback and incorporate it into the latest version of the Functional Guide. Once the guide has been approved by the SISC it will be sent out for community review.
- The Technical Workgroup met on November 16<sup>th</sup> and reviewed the discussion and outcomes from the October call. On the last call, the workgroup agreed to include a demographic only profile in the next version of the Implementation Guide (IG). Rob Savage was invited to discuss what this might look like. The workgroup decided to include a demographics only use case in the IG, but provide guidance that if systems by local agreement decide to exchange demographic only data, they do it using an Admit, Discharge and Transfer (ADT) message, and that the ADT message mimic the format of the unsolicited vaccine record update (VXU) message as closely as possible. The workgroup would also redefine the VXU to include at least one order group. Due to the holidays, the December SISC Technical workgroup meeting has been canceled.

## **Education Steering Committee**

- The Education Steering Committee (ESC) met on November 16<sup>th</sup> and reviewed the latest and nearly finalized draft of the Education Survey which will be sent out to the AIRA membership before the end of the year. The next edition of <u>Snapshots</u> is set to be released in mid-December.
- The ESC will be hosting a webinar on Getting Meaningful Use Stage 3 Ready on December 19<sup>th</sup> at 4pm ET. For more information, including registration details and a calendar appointment, please visit the <u>AIRA website</u>.

## **MIROW Steering Committee**

• The MIROW Steering Committee met on November 17<sup>th</sup> and welcomed two new committee members, Tracy Little from OR and Amy Metroka from NYC. The steering committee started preliminary planning for an in-person strategic planning meeting for next summer. The goal is to develop strategies for updating current MIROW reference materials and new topics moving forward. The current topic, consolidating records, is still underway and will be in progress until spring/summer of 2017.
