## IIS TRANSPORT ASSESSMENT REMEASUREMENT

As part of its IIS Assessment project, AIRA has just published the <u>Transport Assessment Aggregate</u> 3-month Remeasurement Report for December 2016. Thank you to all the IIS who participated in the transport measurement. Measures and tests are developed by the Measurement for Assessment and Certification Advisory Workgroup (MACAW), a representative group of IIS programs, vendors and partners, and approved by the AIRA Board.

A total of 57 IIS (which included all 50 states, plus Washington DC, New York City, Philadelphia, Puerto Rico, San Diego, San Antonio, and the Virgin Islands<sup>1</sup>) were asked to voluntarily participate in the IIS Transport Assessment. Of the 57 IIS, 44 IIS opted to participate in the IIS Transport Assessment for the 3-month snapshot measure in December 2016. This was an increase of 4 IIS over the initial baseline measurement in September 2016.

Of those 44 IIS participating in the transport baseline measure, 26 had a SOAP Web Services/CDC WSDL end point available for testing. This is an increase of 5 IIS since the baseline measurement in September 2016. Specific results for each test were as follows:

<sup>\*</sup> One IIS was unable to be tested for the Submit Single Message operation at the time of this report. They have been included in the Connectivity Test and Security Fault numbers above, but are not included in the Submit Single Message numbers.

Of the 26 IIS with an end point available for testing:

- Six IIS met all three tests, and thus met the measure overall (+1 since baseline).
- 14 IIS met two out of three tests, with all 14 cases missing the security fault test.

**Note:** The 14 IIS that passed all measures except the Security Fault are interoperable with the CDC WSDL standard as long as the correct authentication parameters are sent. For this reason, these sites are functionally compatible for production use when authentication succeeds (+2 since baseline).

- Four IIS met one out of three tests (+2 since baseline).
- Two IIS met zero out of three tests (+1 since baseline).

Individualized reports are available to participating IIS within <u>AART</u> (Aggregate Analysis and Reporting Tool). The next re-measurement for Transport Assessment will take place in March 2017, and will likely include a fresh numerator and denominator as more IIS adopt SOAP/Web Services and the CDC WSDL, and opt to participate in Transport Assessment. # TECHNICAL ASSISTANCE FAQ: MESSAGING FOR VACCINE TYPE

Featuring answers to frequently asked technical questions

Q: Which language codes should an IIS support in PID-15?

A: If you are supporting PID-15, think carefully about what codes you are using and document well. As always, we recommend that you not reject an entire message because of an error in a non-critical field. Language codes are quite complex as there are a number of value sets in use, so variation is possible in this area. Here is what we know at this point:

- IG Release 1.5 has a primary language as an optional element but identifies ISO639 should be used for Language and references a PHINVADS value set. But PHINVADS seems to have adopted the ISO 639-2B variant which contains 3 character codes based on the language name in English (as opposed to the native language)
- The draft 2017 ONC Standards Advisory references RFC 5646 which encompasses another of other standards including ISO 639. RFC 5646 requires the shortest available code (which would normally be 2 character codes from 639-1 but if a language isn't coded in 639-1, then a 3-character code from some other version of 639 would be used.)

Q: How should EHR message and IIS receive non-consenting patients?

A: The IG specifies how to use PD1-12 to indicate if the patient data needs to be protected but doesn't mention under which conditions protected data should be transmitted to the IIS or not. This is because the IG doesn't cover the triggering of individual messages. The triggering of messages is anticipated to be included in the future functional guidance document. For now, submitters should anticipate that some IIS may require that non-consenting patients not be transmitted. This is a topic that still requires more discussion and we are interested in how local policy, regulations and requirements drive technical requirements.

# NEWLY PUBLISHED RESEACH: TDAP AND INFLUENZA VACCINE COVERAGE AMONG PREGNANT WOMEN IN MINNESOTA

The CDC's recent Morbidity and Mortality Weekly Report (MMWR) featured a study from Minnesota on Tdap and Influenza vaccination coverage among pregnant women. The study used data from the IIS and vital records to assess vaccination coverage. An excerpt is below:

Overall, coverage with Tdap vaccine was 58.2% and with influenza vaccine was 45.9%. Coverage was higher for each vaccine among women who received adequate prenatal care compared with those who received inadequate or intermediate care, based on the initiation of prenatal care and the number of recommended prenatal visits attended. Coverage also varied based on mother's race, country of birth or region, and other demographic characteristics. Further study is needed to better understand the maternal vaccination disparities found in this study and to inform future public health initiatives.

# JANUARY RECAP

## **Assessment Steering Committee**

- The Assessment Steering Committee (ASC) met on January 3<sup>rd</sup> and received a progress update on the Addendum to the Analytic Guide and phase II of the Data Quality Project. The Addendum is currently in the graphic design process and a finalized version has been sent to the AIRA Board and participating IIS for review and comments. Interviews to gather information on data monitoring have been conducted with several IIS for phase II of the Data Quality Project. AIRA hopes to have a full phase II data quality guide for the ASC to review during the February meeting.
- The ASC has convened a small workgroup to develop a guide for communicating NIS/IIS coverage assessment results. Their goal is to have the final guide published in summer 2017.

## Standards and Interoperability Steering Committee

- The Standards and Interoperability Steering Committee (SISC) met on January 11<sup>th</sup>. Stuart Myerburg (CDC) and Liz Smith (Deloitte Consulting) provided an overview on the Vaccine Code Sets Management Service (VCSMS). They are developing a pilot project as a new mechanism to manage and deliver immunization code sets in a more flexible way. Ken Gerlach also led a discussion on the unit of sale serial numbers in 2D barcodes. The committee will share their initial stance on whether or not the serial number is a key piece of data that needs to be captured or exchanged with the community.
- The SISC Technical Workgroup met on January 25<sup>th</sup> and discussed how to build a fully populated set of messages, both VXU and RSP, that contain things like contraindications, evidence of immunity and adverse reactions.

## **Education Steering Committee**

• The Education Steering Committee (ESC) met on January 18th and began planning their next webinar. The committee agreed to host a webinar on the Functional Standards in late March as a way to set up the session for the AIRA 2017 National Meeting. The committee also began to plan the next edition of SnapShots which will be released in

late March. This issue will preview parts of the AIRA 2017 National Meeting and will highlight the accomplishments of different IIS throughout the country.

# MIROW Steering Committee

• The MIROW steering committee met on January 19th and welcomed a new steering committee member, Baskar Krishnamoorthy from Florida. MIROW continues to plan for an in-person strategic planning meeting for the summer. The goal is to develop strategies for updating current MIROW reference materials and new topics moving forward. The MIROW steering committee will also be presenting a workshop at the 2017 AIRA National Meeting to solicit input from the community on key aspects for this strategic planning. The current topic, consolidating records, is still underway and will be in progress until spring-summer 2017.
