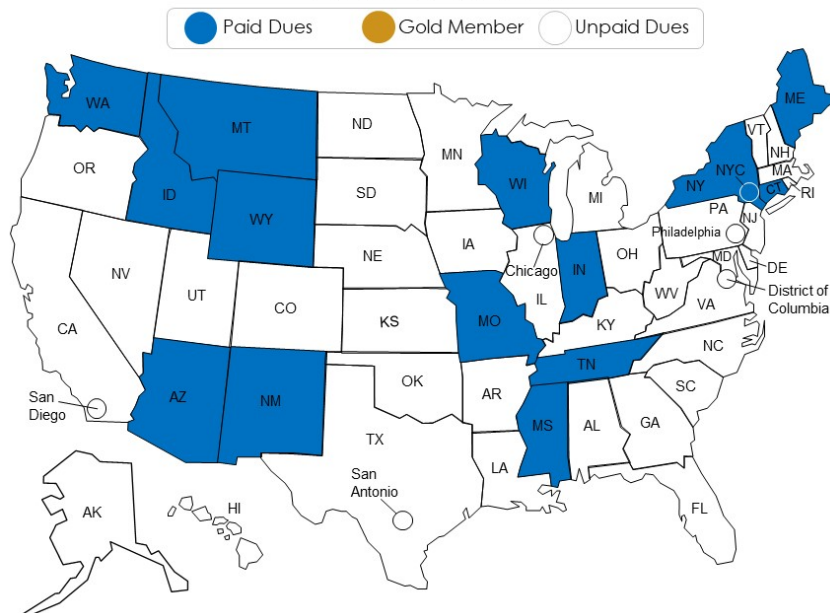
RENEW YOUR AIRA MEMBERSHIP

CDC ALL-AWARDEE MEETING HELD IN ATLANTA

CDC held their 2017 Immunization Awardee Meeting (IAM) on August 23-25 at the Global Communications Center at the Clifton CDC Campus. The theme of the meeting "IAM Moving the Needle" was intended to remind the immunization community that our work across the immunization field has a significant impact the well-being of our communities and society as a whole.

The meeting brought together Immunization Program Managers and staff, IIS Managers and staff, partners such as Indian Health Services (IHS), AIRA and the Association of Immunization Managers (AIM), CDC staff and Public Health Advisors (PHAs), and others to hear about and discuss current topics, many of which were extremely relevant to the IIS community. Not surprisingly, funding was a critical topic of discussion. Dr. Nancy Messonnier and Alexander Harrington from the Office of the Director at NCIRD underscored that more information will be shared as the President's proposed budget moves through Congress toward appropriations.

Staff from the IIS Support Branch Operations Team facilitated several popular sessions, including:

- A discussion on IIS Sustainability, focusing on opportunities to access and leverage 90/10 match funds and creative partnerships with Medicaid, health plans and health systems.
- Presentations on IIS-EHR interoperability that included overviews from Nebraska, North Dakota, Arizona, Louisiana, and Kansas.
- A panel on transitioning to a new IIS, with panelists representing California, New Mexico and Texas.

All five Branch Chiefs, including our IISB Branch Chief Warren Williams, provided summary successes from the 2013-2017 Cooperative Agreement period; for IIS, these highlights included increased interoperability accelerated by Meaningful Use, the growth of vaccine management functions in IIS prompted by VTrckS ExIS interfaces, increases in standardization

resulting from stronger standards and measurement efforts, and expanding data use opportunities through AFIX functionality.

CDC announced during the meeting that awardees can access all presentations from the IAM sessions on the CDC Sharepoint site following the meeting.

The updated resources reflect the new 2017-18 Influenza recommendations along with some clarification updates to Tetanus, Diphtheria, Polio, and Yellow Fever. GOLD MEMBER HIGHLIGHT: NEW VERSION OF HLN'S OPEN SOURCE IMMUNIZATION FORECASTER RELEASED

A new release (v1.8.2.0) of the Immunization Calculation Engine (ICE) is now available. ([Download ICE v 1.8.2.0](#)). ICE is a state-of-the-art open-source software system that provides clinical decision support for immunizations (CDSi) for use in Immunization Information Systems (IIS), Electronic Health Record (EHR) and Personal Health Record (PHR) Systems.

The release includes the following changes:

- Updates to the [Polio Vaccine Group](#) and the [Meningococcal ACWY Vaccine Group](#) to better reflect latest guidelines, and addition of Influenza vaccine (CVX 185 and 186) to the [Influenza Vaccine Group](#).
- Combines PCV and PPSV vaccine groups into one, new vaccine group for Pneumococcal. This change was made to better account for shots administered across the patient's lifetime. (To support this new Pneumococcal vaccine group, implementers may need to make adjustments to stop looking for the old PCV and PPSV vaccine group codes (700 and 720), and start looking for the new vaccine group code (750). Child and adult pneumococcal vaccinations are now evaluated and forecast under this new vaccine group. The PCV and PPSV vaccine groups are no longer supported.)
- [Release notes](#) which describe the above changes to the vaccine group logic in more detail.

Implementers should refer to the new [ICE Implementation Guide \(v2r15\)](#) when making adjustments to be compatible with this latest release, including the new Pneumococcal vaccine group as well as a few other vaccine and evaluation reason codes that have been added. (A "[track changes](#)" version of the guide is also available to make it easy to see what has changed since the last release.)

You can determine which release of ICE you are using by viewing the README.HISTORY file that is included with each distribution.

JULY RECAP

Assessment Steering Committee

- On August 15th, the Assessment Steering Committee (ASC) hosted a webinar to introduce [Practical Examples of IIS Population Based Coverage Assessments: An Addendum to the Analytic Guide](#). This webinar featured speakers from New York City, Minnesota and Washington state, who each use their IIS data in different ways to conduct coverage assessments.
- The ASC has moved to a quarterly meeting format. The next meeting will be held on September 5th at 2pm ET.

Standards and Interoperability Steering Committee

- The Standards and Interoperability Steering Committee (SISC) met on August 9th and approved sending AIRA's comments on the 2018 updates to the MACRA 2018 Rule. An overview was given on a recent pilot about delivery management service options for

vaccine code sets in preparation for the discussion on the technical workgroup call. The committee discussed state boundary query challenges for EHR's and reviewed July's SISC Technical Workgroup's discussion on patient query demographics and various LOINC codes.

- The SISC Technical Workgroup met on August 23rd and further discussed state boundary querying. In addition, the workgroup continued reviewing the HL7 ballot comments that were submitted. The topics included various LOINC codes including required LOINC codes. This will be a reoccurring agenda item until the comments are reconciled.

Education Steering Committee

- The Education Steering Committee (ESC) met on July 19th and received an update from the Public Health Informatics Institute's Informatics Academy. The next edition of *SnapShots* is scheduled to be published this fall and the Education Survey Report is currently in the design stage.
- The ESC hosted a webinar on schools and childcare within the IIS on Tuesday, August 29th. Oregon, Washington State, Indiana, and other IIS shared how they utilize school and childcare modules. The webinar also provided an overview of the Family Educational Rights and Privacy Act (FERPA). If you were unable to attend the webinar, you can view the recording [here](#).

MIROW Steering Committee

- The MIROW Steering Committee (SC) cancelled the August call due to the strategic planning in-person meeting held earlier in the month. For an update on the current status of that meeting see above article. The current topic, Consolidating Records, has completed the external review process and the document is currently in the design phase, with an anticipated September/October publication date.
