Introduction

AIRA receives funding from the Centers for Disease Control and Prevention (CDC) to provide technical assistance (TA) to immunization information systems (IIS) and their partners. This TA is provided to increase IIS alignment with national standards and improve interoperability between IIS and data exchange partners with an emphasis on data quality. TA is defined as non-financial assistance provided by local specialists and includes sharing information and expertise, instruction, skills training, transmission of working knowledge, and consulting services. AIRA prioritizes group TA, TA directly related to Measurement and Improvement (M&I), and TA that assists IIS in better aligning with national standards. AIRA's TA offerings also include digital and onsite options to meet a range of needs, including provider onboarding, epidemiology support, and data visualization services.

AIRA has a wide range of expertise to assist the IIS community, including:

- Technical Health Language Seven (HL7) and interoperability expertise
- Provider onboarding
- Smarty address cleansing implementation assistance
- System testing and enhancement strategies
- Consultation on development of reports and other data outputs
- Development of data quality plans and strategies
- Discussion of policy and staffing challenges
- Development of business continuity plans
- Data analysis and visualization
- Requirements development

AIRA closely collaborates with CDC and the Public Health Informatics Institute (<u>PHII</u>) to collectively support IIS and immunization programs. This catalog documents AIRA's available services and resource offerings to the IIS community.

General Responsive TA

Project-Based TA	Subject to available funding, staff, and/or sponsor/leadership approval, AIRA staff are available to provide TA via webinars, individual/group virtual meetings, and other digital platforms. This requires a project charter that outlines goals, deliverables, resources (AIRA and IIS program), and a timeline. Projects have varying duration needs, ranging from weeks to months. Topics include but are not limited to: IIS staff mentoring and coaching Data analysis/epi support Data visualization support Data quality plan and strategy development Business continuity plan development Program/project recommendations

It's intended to capture and understand jurisdictional onboarding practices and documentation, identify priority onboarding assistance needs and opportunities, and deliver recommendations for improvement to a jurisdiction's onboarding processes.
