Vaccine Credentials

- No federal guidance
- AIRA & key IIS subject matter experts developed a “working guide” – goal is to gather and document common terminology and references

Clinical Trial Participant Data

- CDC guidance 6/18/21
- AIRA is working on additional aspects (lot numbers, etc.)
- Issue will likely grow given school and/or childcare requirements
- **FYI**
 - Each clinical trial site is independent – no central data repository
 - May or may not have electronic record keeping



Status of Clinical Trial Administration Data and the IIS

Not all clinical trial sites are currently connected to the IISs for data sharing. If clinical trial data is sent to an IIS, it is appropriate to accept the doses as valid and include in data reports under certain conditions. For a dose of COVID-19 vaccine used in a clinical trial to be considered valid, **all** the conditions outlined below must be met.

Conditions Required to Validate Clinical Trial Vaccine Doses

A patient that received trial vaccine **under all of the following conditions** can be counted as a valid recipient, and the administration data can be accepted into the IIS and reported to CDC:

- The vaccine received has been authorized by FDA or listed for emergency use by WHO.
- The individual received the trial vaccine and not the placebo (or comparator vaccine – for future studies).
- The individual received a dose volume that is at least half of the currently authorized dose of the vaccine.
 - This condition includes all persons who participated in a phase 3 trial and some that participated in phase 1 or 2 trials.
- The vaccine was administered per an ACIP or WHO schedule (e.g., age, interval).

IISB Information Brief



IIS access/data use

- Variety of new (and old) entities interested in obtaining access to IIS
- Opportunity for public health to shine
- Many jurisdictions are exploring options for making data available – here are some of those options
 - Establishing rules for querying (e.g., times for large queries)
 - Establishing systems for querying outside of the “live” IIS (e.g., data lake)
- AIRA is working with SMEs to help identify best practices

 - Recommendations 12-17 are specific to immunizations

- EHR Reporting Program Draft Developer Measures also presented on the July 14 HITAC meeting, draft measures include two on public health information exchange:
 - *How frequently are providers using their certified health IT to send immunization/vaccine information to IIS?*
 - *How frequently are providers using their certified health IT to query IIS for immunization forecasts and histories?*

- ONC continues to work with our Strengthening the Technical Advancement & Readiness of Public Health via Health Information Exchange Program (STAR) and Immunization Data Exchange, Advancement and Sharing (IDEAS) awardees, including ASTHO, to help communities improve the sharing of health information related to vaccinations. - The Office of the National Coordinator for Health Information Technology (ONC) has received \$80 million to implement or expand training, certification and degree programs in public health informatics and data science at minority serving institutions (MSIs) and other colleges and universities. PRODUCT NUMBER: V2010

DESCRIPTION: Brightly colored red, round button with white text, and a metal pin that clasps on the back. Pin on your lab coat, uniform, other clothing, tote bag, or backpack to show your support for influenza vaccination. Wear it when flu vaccine is available in your clinic to remind your patients and the public to protect themselves from influenza. Demonstrate your clinic-wide support for protecting everyone from influenza by giving buttons to all staff. Button is understated in size, measuring 1.25" across, but carries a bold message!

Encouraging everyone to wear them at work during vaccination season is a powerful reminder for patients to get vaccinated. 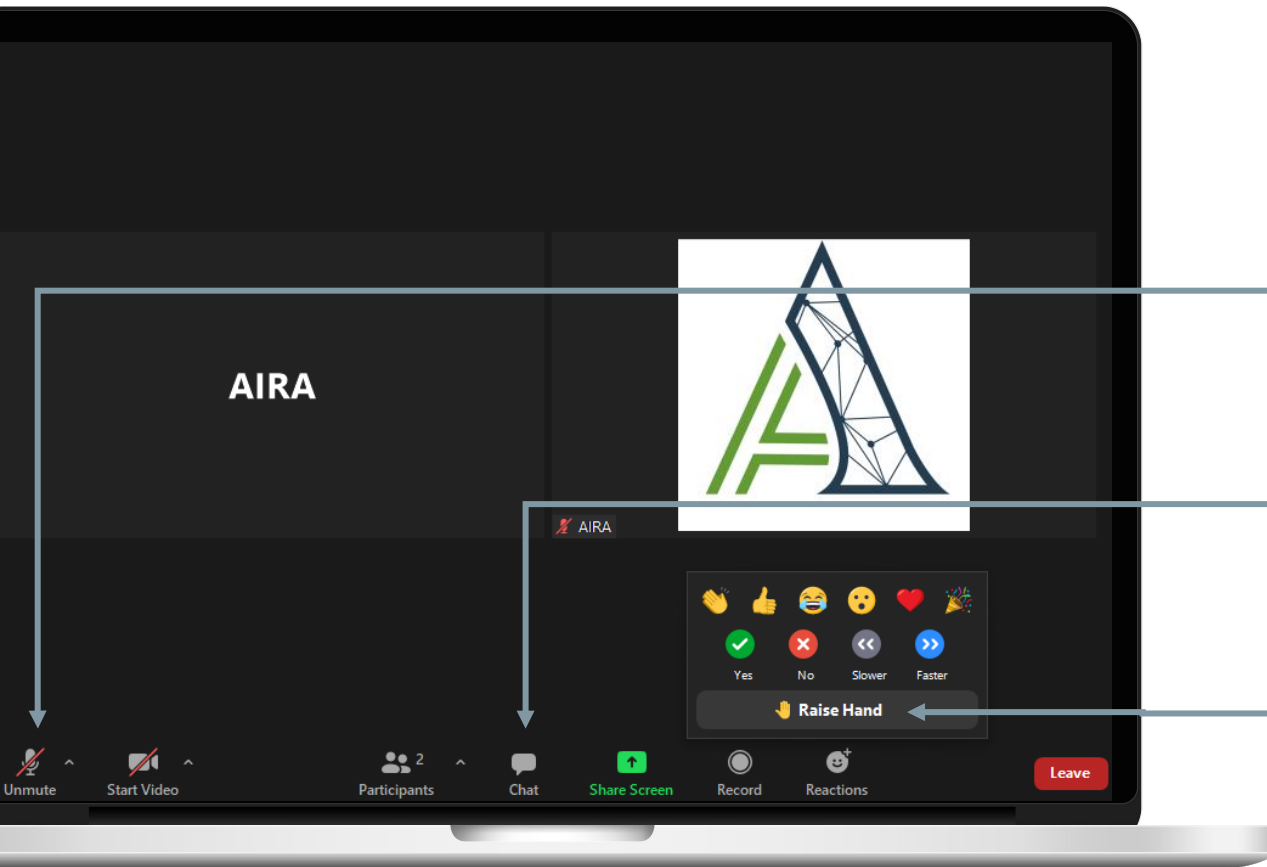

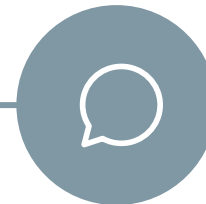

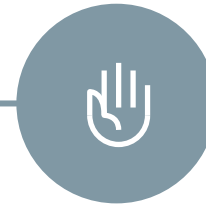
