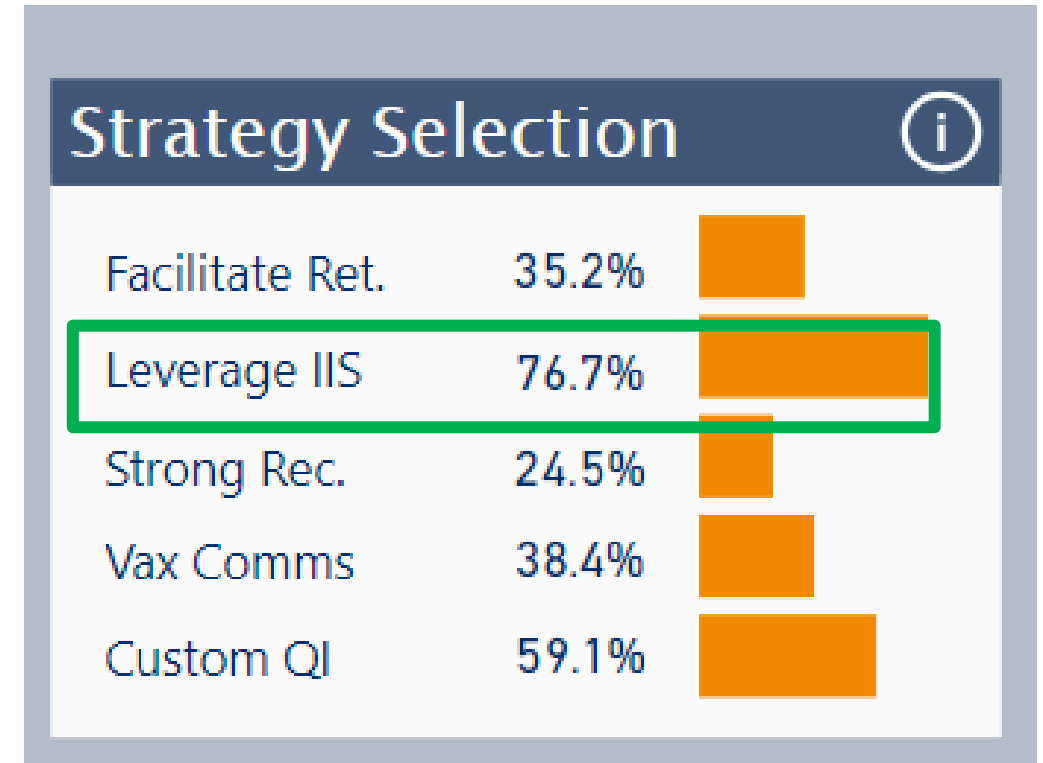

IIS Resources for Quality Improvement Activities

- Leveraging IIS quality improvement tools and reports is the **most chosen strategy among clinics**
- IIS QI tools and reports are used for monitoring and improving immunization efforts and data quality to meet state and national standards



IIS Resources for Quality Improvement Activities

Commonly used IIS tools for QI:

- IIS Coverage Rate Report
- Reminder/Recall
- Patient Detail Report
- Lot Usage and Recall Report
- Consolidated Patient Records and Forecasting
- IIS Management of Patient Ownership Status



IIS Resources for Quality Improvement Activities

Immunization Quality Improvement for Providers

- CDC's national Vaccines for Children (VFC) provider-level immunization quality improvement program
- Quality improvement program to support providers improve vaccine uptake



IIS Resources for Quality Improvement Activities

IQIP

- Around 250 WA Childhood Vaccine Program enrolled clinics participate each year
- IIS quality improvement tools are used in primary strategies for IQIP activities
 - **Reminder/Recall**
 - **Coverage Rate Report**
 - **IIS Patient Ownership and Status Management**



IIS Resources for Quality Improvement Activities

Immunize Washington

- Annual state award to recognize high vaccine coverage rates for children and adolescents
- Used to support IQIP activities
- Hosted by the Health Plan Partnership
 - WA DOH, HealthCare Authority, HPV Free Task Force, Within Reach, and major health plans in WA, & WACAAP

IIS Resources for Quality Improvement Activities

Immunize Washington

- Formal recognition for winners
 - Certificate signed by the Governor, window cling for clinic, and yearly awardee list posted on WA DOH website
- Self-nomination by providers using the **IIS Coverage Rate Report**
- **Gold**, **Silver**, and **Bronze** level awards

IIS Resources for Quality Improvement Activities

Immunize Washington

- 2024 is the 10-year anniversary
 - Now includes an award level for HPV initiation among 9- & 10-year-olds



IIS Resources for Quality Improvement Activities

HPV at 9

- Research-based campaign to start vaccinating against HPV at 9
- **WA IIS Forecast** changed in January 2023 to prompt HPV dose 1 at 9
- **Coverage Rate Report** utilized for analyzing patient coverage
- **Reminder/Recall** used to increase vaccination rates

Schedule / Attend a WAIS Training on QI Tools. Make a strategy to share immunization rates monthly with staff.

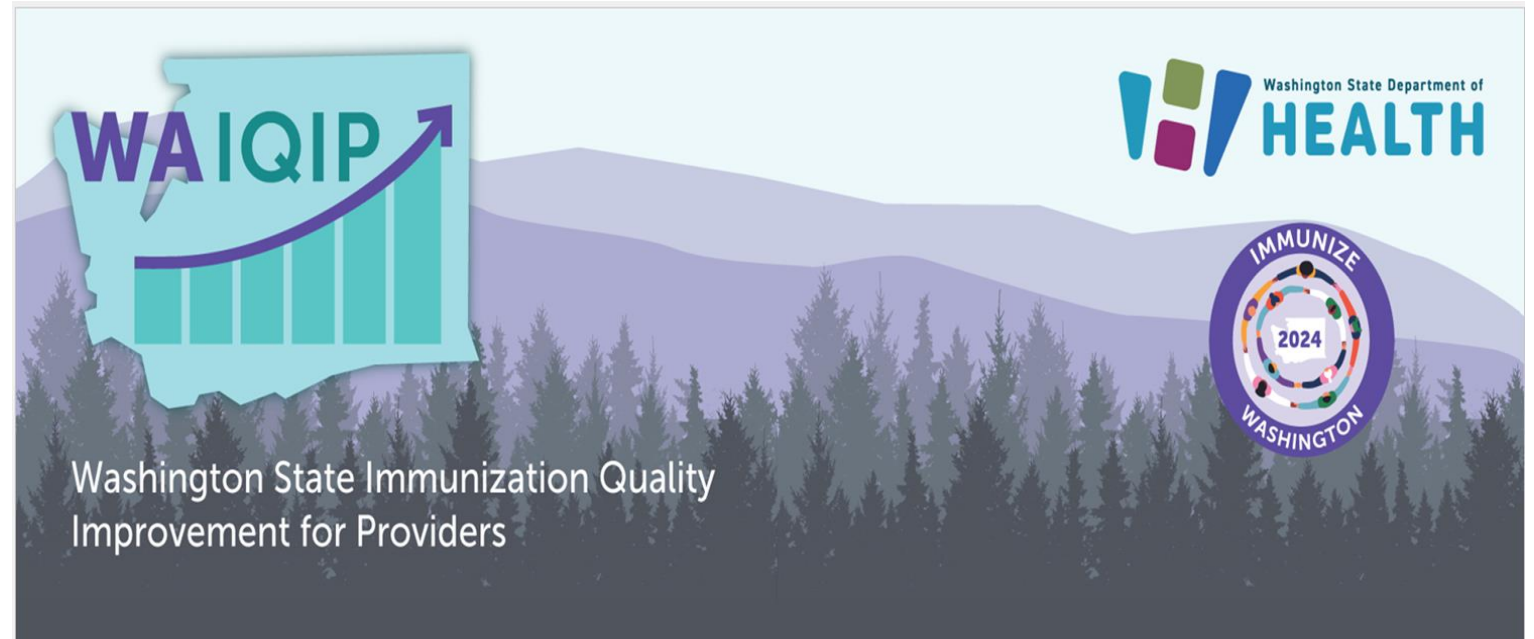

About

[Vax Northwest](#), an initiative of [WithinReach](#) and the Washington Department of Health (DOH) [Immunization Quality Improvement for Providers program \(IQIP\)](#), have collaborated to distribute a resource, the Reminder/Recall Letter Template.

The letter is translated into 11 languages (see image for specific languages) for Washington state healthcare providers and clinics' use. Research shows that reminder/recall methods work to improve immunization rates and well child visit appointments while reducing no shows.^{1,2,3} Vax Northwest and DOH hope this template will be a tool to help clinics and organizations keep patients up to date with recommended vaccines, increasing immunization rates and improving the health of our community.
