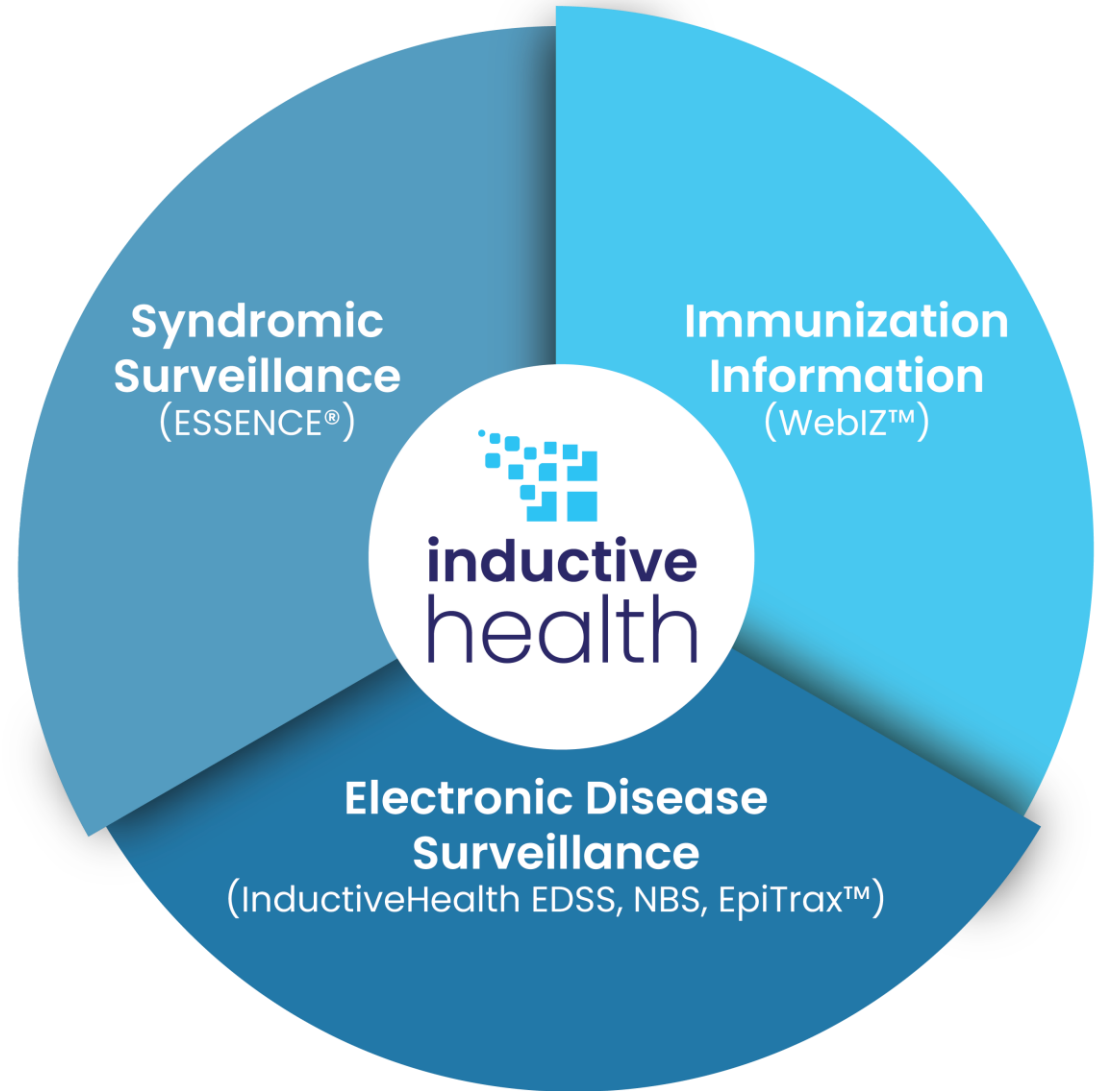

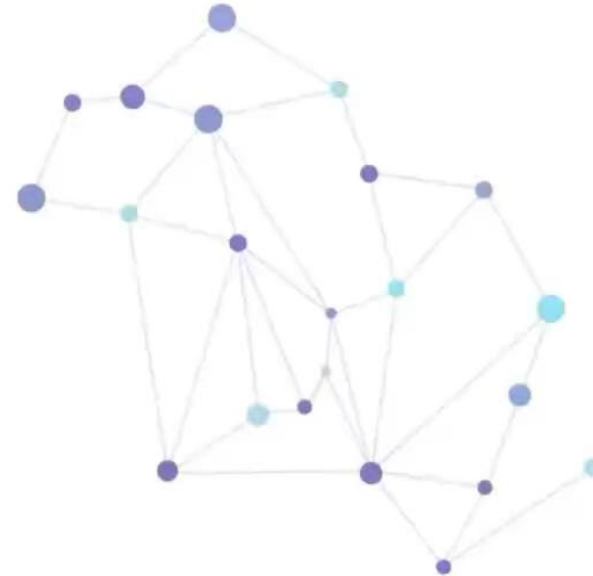

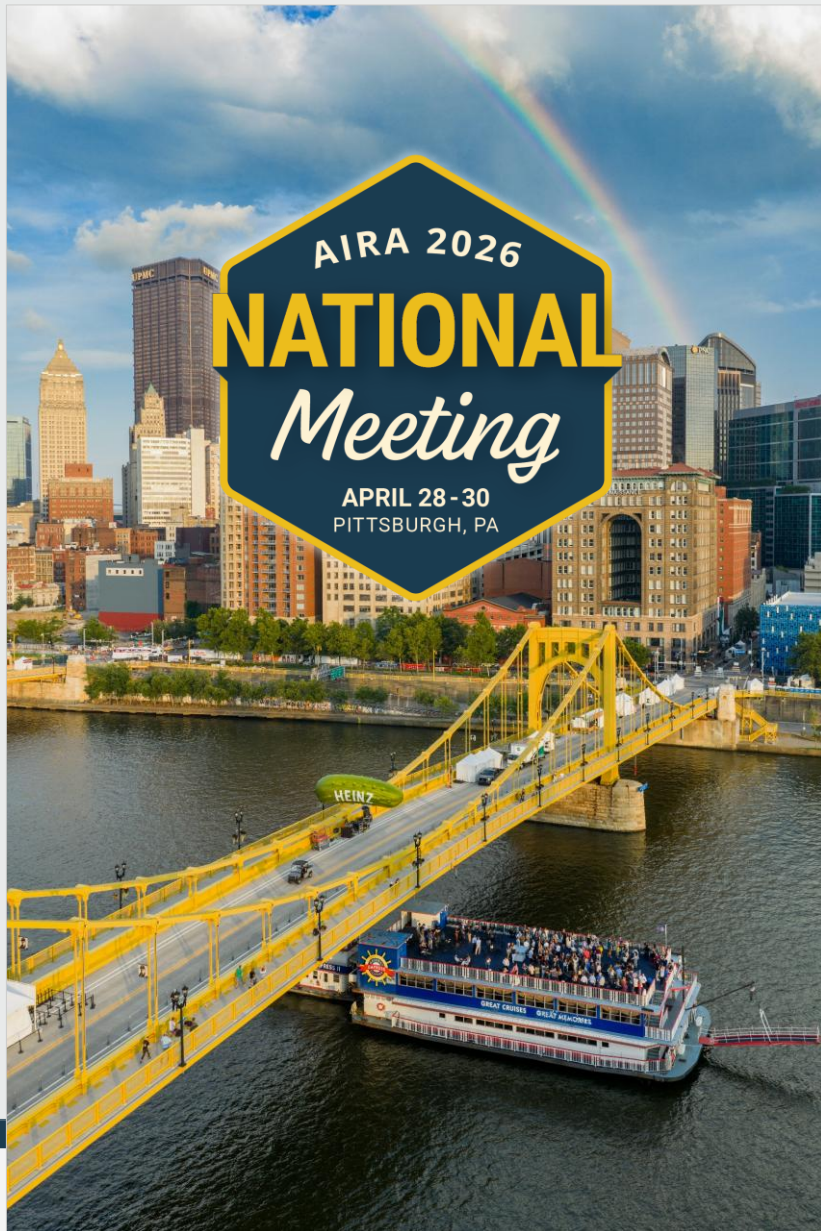

## Jurisdictional Immunization Information System (IIS) or Registry



IIS consolidates records from  
multiple sources

Sources send & receive  
vaccination records

### Healthcare Providers

Use information to see  
which vaccinations their  
patients have had and  
may need

### State and Local Public Health Authorities

Use data to develop programs to increase vaccination coverage, decrease harm from VPDs (e.g., manage outbreak response), manage vaccine, etc.

### Parents, Patients, and General Public

Use records to enroll children in schools and daycare and determine when they need vaccinations. (e.g., through a consumer access portal)

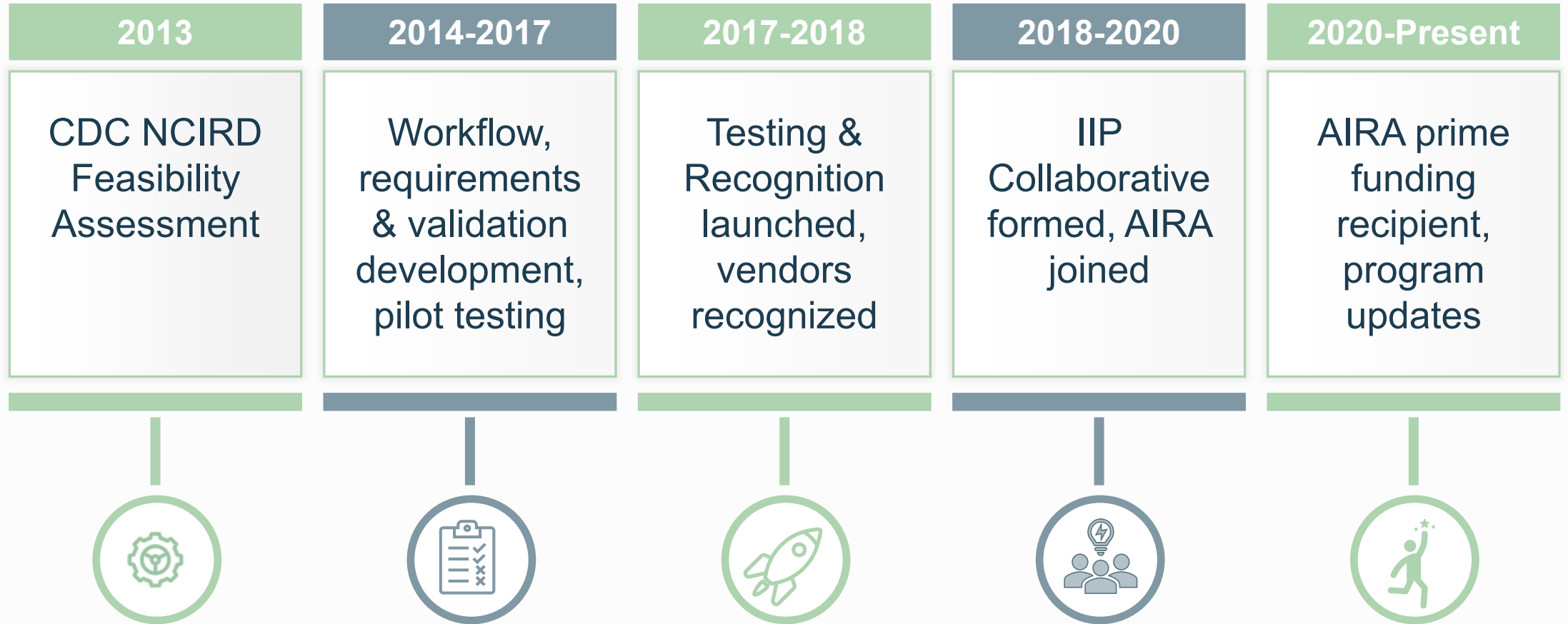


# IIP Partnerships

- Parallels AIRA's Measurement & Improvement initiative
- 8 vendor products tested and recognized 9/2017-1/2025; currently testing CureMD
- IIP test plan recently converted to a modular format to maximize testing flexibility and efficiency
- Developing an advanced data quality testing module

# A Little Bit About our IIS: Nevada WebIZ

- Nevada WebIZ (or NV WebIZ) has been in use since 2003, and reporting became mandatory in 2007 (for children) and 2009 (for adults).
- As of March 2026, the system contained over 5.6 million patient records, which include over 69 million vaccinations.
- Over 2,000 public and private authorized organizations in over 3,300 locations, including medical practices, hospitals, local health authorities, school districts, and child care facilities, have access to view, add, and/or update immunization information for Nevada's communities.

# Measurement: Providing Support and Synergy



## Impacts of Measurement Through the IIS Lens

- ❑ **For Clinicians:** More accurate clinical decision support for immunizations
- ❑ **For EHR vendors:** Better acknowledgement messages, fewer data errors or missed data
- ❑ **For constituents across my state:** More complete data for individual consumer records, school requirements, etc.
- ❑ **For our Federal partners:** Standardized onboarding for exchange with Veterans Health Administration (VHA) and Department of Defense (DoD) through the IZ Gateway
- ❑ **For my team and my leadership:** Better reports and performance data from my system

# Progress Builds, Continues to Evolve

## 4) Standards

Written broadly, needed to be clarified and modernized.



## 1) EHRs and Clinicians

Systems were modernized as part of Meaningful Use – Regulation and incentive payments accelerated the process

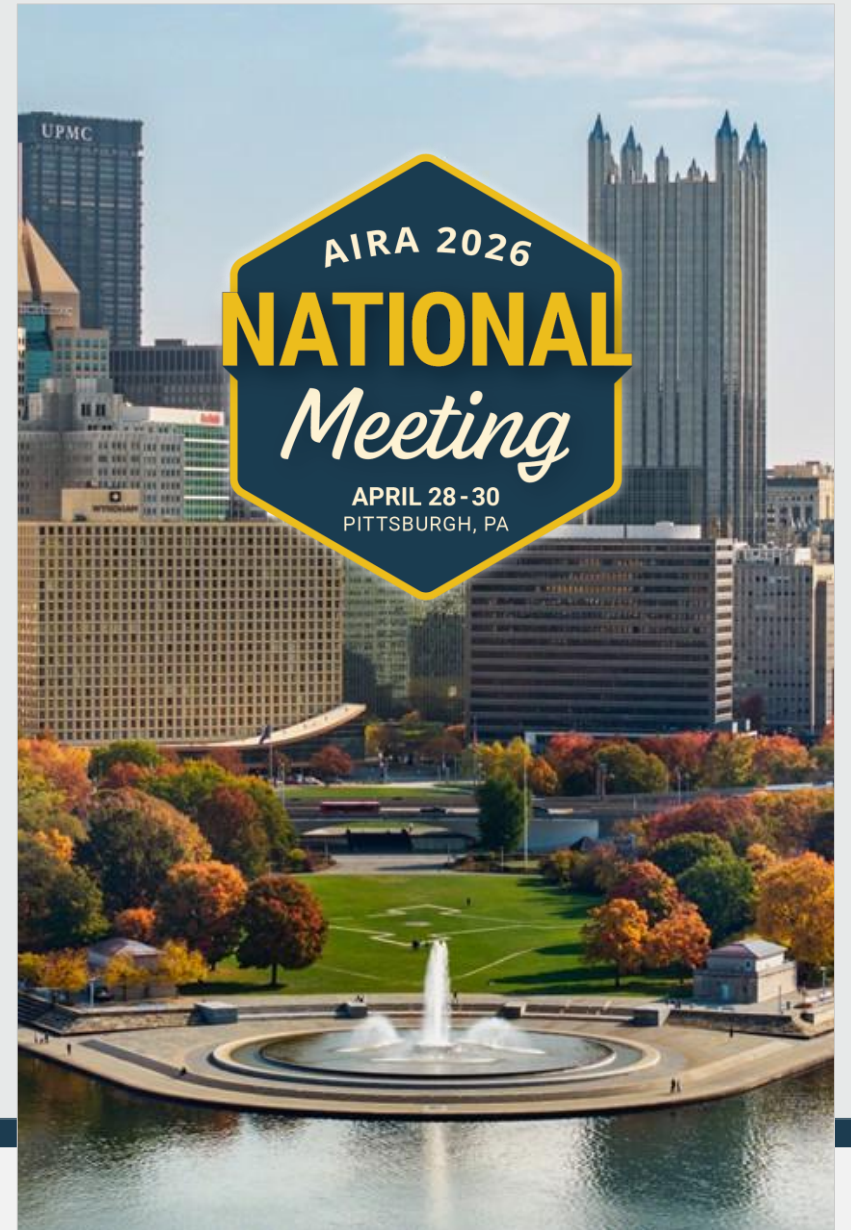
# The IIS, EHR, Provider Trifecta

- Accurate, complete, and timely immunization data depends on all three players functioning as an integrated system
- Provider trust in data = increased utilization = further investment in data quality and system improvement

# IIS Validation – What Is It?

*Validation is a **summary stage** to formally acknowledge and recognize **IIS and IIS vendor products** that are progressing toward or achieving **alignment with community-selected measures and tests***



# IIS Validation – Who Is Taking Note?

- IIS data exchange partners
- CDC funders/sponsors
- Health payers (inc. CMS)
- ONC and others supporting rule and regulation across Health IT

*Vendor validation is especially helpful as an evaluation tool for IIS going through the procurement process*
